On March 4, 2021, it was discovered that the Alamodome Arena System Amplifiers on the north end of the arena suffered severe damage due to the recent winter weather event in Texas during the week of February 15th. Extraordinary freezing temperatures and rolling power outages contributed to the system's failing. The system needs immediate repair to accommodate upcoming events such as next week's UIL Boys & Girls Basketball Tournament, followed by the NCAA Women's Final Four Tournament.
