The City Council convened in a Special City Council Meeting at 2:00 pm. The City Clerk took the Roll Call with the following Councilmembers present:

**Present:** 9 - Castro, Bernal, Taylor, Viagran, Saldaña, Lopez, Nirenberg, Krier and Gallagher

**Absent:** 2 - Gonzales and Medina

The City Clerk read the caption for Item 1:

**2014-05-21-0361**

1. An Ordinance declaring the official results of the Special Election for City Council District 9 held on Saturday, May 10, 2014. [Leticia M. Vacek, City Clerk]

Mrs. Vacek presented a Power Point of the Official Results of the May 10, 2014 Special Election for District 9 and 10. She reported that the Total Votes Cast was 5,923 and that the number of Registered Voters for District 9 was 90,358. She stated that Voter Turnout for the District 9 Special Election was 6.56%. She noted that no Overseas or Provisional Ballots were returned.

Mrs. Vacek read the following results:

Joe Krier	3,367 votes
Weston Martinez	1,225 votes
Bert Ceconi	189 votes
Donald Oroian	899 votes

Mrs. Vacek declared that as a result of the election, Joe Krier was elected as the Councilmember for District 9.

MEMBER OF COUNCIL, PLACE NO. 10 - ELECTION CANCELLED

Michael "Mike" Gallagher Declared Elected

Mrs. Vacek reported that on March 11, 2014, per Section 2.053(a) of the Texas Election Code, Michael "Mike" Gallagher was an unopposed candidate for Member of Council, Place No. 10. She stated that on March 20, 2014, Michael "Mike" Gallagher was declared elected and the District 10 Special Election was cancelled.

Mrs. Vacek administered the Statements of Elected Officer and Oaths of Office to newly elected Councilmembers Joe Krier and Mike Gallagher.

Mayor Castro presented the Certificates of Election to Councilmembers Joe Krier and Mike Gallagher. He congratulated them on their election and welcomed them to the City Council. Councilmembers Krier and Gallagher addressed the City Council and stated that they looked forward to serving the citizens of San Antonio.

Councilmember Bernal moved to adopt the proposed ordinance canvassing the Election Results. Councilmember Taylor seconded the motion. The motion prevailed by the following vote:
