

AN ORDINANCE 2015-12-10-1047

AUTHORIZING AN AMENDMENT TO THE EXISTING CONTRACT WITH BUCK CONSULTANTS, LLC, TO EXTEND THE TERM OF THE CONTRACT ON A MONTH-TO-MONTH BASIS, BEGINNING JANUARY 1, 2016, WITH NO ADDITIONAL FUNDING.

WHEREAS, the City of San Antonio issued a Request For Proposals for professional consulting services; and

WHEREAS, after conducting an evaluation process, City Staff recommended Buck Consultants, LLC be selected to perform the employee benefit consulting services under the contract; and

WHEREAS, said Contract provided for a one year term, expiring on June 19, 2015; and

WHEREAS, the parties later amended the terms of the contract to extend the contract term through December 31, 2015; and

WHEREAS, the parties now wish to amend the term again to allow for a month-to-month extension, beginning January 1, 2016, on an as needed basis, at the City's option, contingent on the availability of current funding; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The City's contract with Buck Consultants, LLC is hereby amended to extend the contract on a month-to-month basis beginning January 1, 2016, on an as needed basis, at the City's option, as set forth in Attachment 1. The City Manager, or her designee, is authorized to execute the Amendment and Extension, attached hereto and incorporated herein as Attachment 1.

SECTION 2. This ordinance is effective immediately upon passage of eight affirmative votes; otherwise, it is effective ten days after passage.



AMENDMENT AND EXTENSION OF PROFESSIONAL SERVICES CONTRACT

This Amendment and Extension of the Professional Services Contract with Buck Consultant's, LLC, (hereinafter referred to as "CONSULTANT") to provide comprehensive benefits consulting services to the City of San Antonio (hereinafter referred to as "CITY"), is as follows:

WHEREAS, through Ordinance No. 2014-06-19-0463, passed and approved June 19, 2014, City Council authorized the execution of the consulting contract (hereinafter the "Contract"), with CONSULTANT; and

WHEREAS, said Contract provides that CONSULTANT shall provide comprehensive benefits consulting services; and

WHEREAS, CITY and CONSULTANT want to amend the contract term and allow for an extension to begin January 1, 2016 on a Month-to-Month basis provided funds are available and in an amount not to exceed remaining funds from the prior contract; and

WHEREAS, the Parties wish to amend the Contract as set forth in this Amendment and Extension;
NOW THEREFORE:

I. Renewal

Pursuant to the provisions of Section VIII of the Contract, CITY and CONSULTANT mutually agree to extend the term of said Contract commencing on January 1, 2016 on a Month-to-Month basis provided funds are appropriated and under the same terms and conditions as stated in said Contract. This Extension will allow City to complete the Request for Proposals review process.

II. Amendment

Section V. Consideration and Billing, is amended as follows:

5.1 In consideration of CONSULTANT'S performance hereunder, CITY shall pay to CONSULTANT an amount not to exceed the amount of any remaining funds from first Extension.

Section VI. Term, is amended as follows:

This Contract shall be extended on a Month-To-Month basis as agreed to by the parties in writing beginning January 1, 2016 and will continue on a Month-To-Month basis, provided service charges billed do not exceed the amount of remaining funds previously allocated. It is understood by the parties, the Contract ends upon expiration of the remaining funds.

III. Remaining Terms and Conditions


