AWARDING A TASK ORDER CONSTRUCTION CONTRACT TO E-Z BEL CONSTRUCTION, LLC IN AN AMOUNT NOT TO EXCEED \$1,423,791.18 FOR NEIGHBORHOOD TRAFFIC CALMING CONSTRUCTION PROJECTS AT LOCATIONS THROUGHOUT THE CITY.

WHEREAS, City Council approved funding for the FY 2018 Capital Improvements Program; and

WHEREAS, the City's FY 2018 Capital Improvements Program includes funding for the construction of traffic calming devices in various neighborhoods throughout the City. Funding will provide for materials and equipment (i.e. illuminated traffic signs, speed feedback trailers, etc.), engineering services (i.e. consultant design for projects and evaluation) and construction; and

WHEREAS, in January 2018 the City advertised for a Task Order Contract for Traffic Calming Construction and received two responsive bids; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by E-Z Bel Construction, LLC in an amount not to exceed \$1,423,791.18; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid submitted by E-Z Bel Construction, LLC in an amount not to exceed \$1,423,791.18, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever comes first.

SECTION 2. The amount up to \$1,423,791.18 will be encumbered upon issuance of purchase orders, and payment is authorized to E-Z Bel Construction, LLC. All expenditures will be in accordance with the Fiscal Year 2018 and subsequent budgets that fall within the term period of this contract approved by City Council.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
