## AN ORDINANCE 2016-12-15-1001

AUTHORIZING THE SETTLEMENT OF A LAWSUIT STYLED ISABEL ESCOBEDO v. CITY OF SAN ANTONIO, CAUSE NUMBER 2014-CI-05083, PENDING IN THE 150<sup>th</sup> JUDICIAL DISTRICT COURT, BEXAR COUNTY, TEXAS, FOR PAYMENT IN THE AMOUNT OF \$110,000.00.

WHEREAS, Plaintiff Isabel Escobedo is seeking damages as a result of a fall that occurred in the 3700 block of Morales Street in San Antonio on August 25, 2012.

WHEREAS, it is in the City's best interest to settle this matter to avoid the uncertainty and risks associated with further litigation; and

WHEREAS, the parties have reached a mutual agreement to settle all claims for the amount of \$110,000.00 payable from the Self-Insurance Liability Fund subject to City Council approval; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The amount of \$110,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund, General Ledger 5402530 General Liability Claims, Cost Center 7509020001 Risk Management-Liability, and is authorized to be made payable as follows: \$110,000.00 will be paid to plaintiff Isabel Escobedo and her attorney Steve Dummitt, Carlson Law Firm, PC as settlement of Cause No. 2014-CI-05083 styled Isabel Escobedo v. City of San Antonio.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
