AN ORDINANCE

**AUTHORIZING A CATERING AND CONCESSIONS SERVICES AGREEMENT
WITH RK CULINARY GROUP, LLC FOR THE HENRY B. GONZALEZ
CONVENTION CENTER FOR A TERM OF 10 YEARS COMMENCING ON
OCTOBER 1, 2015; AND AUTHORIZING THE TERMINATION OF THE
EXISTING CATERING AND CONCESSIONS SERVICES AGREEMENT
EFFECTIVE SEPTEMBER 30, 2015.**

WHEREAS, In May 2014, the City solicited proposals from experienced, qualified food service providers interested in providing catering, restaurant, concessions and sundry services on an exclusive basis, as well as non-exclusive ancillary and merchandise services at the Henry B. Gonzalez Convention Center and Lila Cockrell Theater; and

WHEREAS, the solicitation was active for eight months with three pre-submittal conferences held in June, July, and December 2014 to allow for potential respondents to ask questions or seek clarification to the solicitation; and

WHEREAS, three proposals were received by the City, however, one was disqualified from consideration for failing to meet the requirements of the City's SBEDA program which included subcontracting goals established by the City's SBEDA Goal Setting Committee; and

WHEREAS, the two remaining proposals were evaluated by a committee comprised of representatives from the City Manager's Office, Convention & Sports Facilities Department, the Convention and Visitors Bureau, the Convention & Visitors Commission, and a convention center client representative (the "Evaluation Committee"); and

WHEREAS, on April 9th and 10th, 2015, the Evaluation Committee convened to interview and evaluate the qualifications of the respondents based on their experience, background, and ability to provide all food and beverage service on an exclusive basis for events held in the Convention Center; and

WHEREAS, based upon the submitted proposals, the interviews of and presentations by the proposing firms, the Evaluation Committee recommends that the City contract with RK Culinary Group, LLC to provide exclusive catering, restaurant, concessions and sundry services and non-exclusive ancillary and merchandise services at the Henry B. Gonzalez Convention Center and Lila Cockrell Theater; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of a Catering and Concessions Services Agreement (the "Agreement") with RK Culinary Group LLC, and a Termination Agreement of the current Catering and Concessions Agreement effective September 30, 2015, are hereby approved.

SECTION 2. The City Manager, or her designee, is authorized to execute the new Catering and Concessions Services Agreement in accordance with this Ordinance. Copies of the Agreement in

substantially final form are set out as “**Attachment I**” and made a part of this Ordinance. Final copies of the Agreement shall be attached upon execution by the Parties.

SECTION 3. Funds generated by this ordinance will be deposited as per the table below:

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall become effective immediately upon its passage by eight (8) affirmative votes and on the tenth (10th) day after its passage on less than eight (8) affirmative votes.
