

ORDINANCE 2019-03-21-0240

AUTHORIZING THE NAMING OF THE LAKE AT MILAM TEALER PARK TO LAKE VERDA LOCATED AT 5640 LAKEFRONT DRIVE IN COUNCIL DISTRICT 2. THERE IS NO GENERAL FUND IMPACT ASSOCIATED WITH THIS ORDINANCE.

WHEREAS, the Lakeside Neighborhood Association, representing individual residents' they serve in the area, has requested that the lake at Milam Tealer Park, 5640 Lakefront Drive be named Lake Verda; and

WHEREAS, the naming of the lake is to recognize Mrs. Verda Tealer, the wife of Milam Wesley Tealer whom the park is named after Mrs. Tealer has been a long time resident of Lakeside, and like her husband, has been a tireless worker and ongoing advocate for the Lakeside community; and

WHEREAS, the association and its members feel that this naming is a fitting tribute for the lady who dedicated her time, talent and monies to the betterment of the overall Lakeside community; and

WHEREAS, in addition, the community has bestowed Mrs. Tealer with the title of "Mother of Lakeside" because she continues to work to ensure every resident, from the children to the residents, are not forgotten and included in everything done by the Lakeside Neighborhood Association; and

WHEREAS, staff followed the naming process in accordance with Ordinance No. 2011-03-31-0239; and

WHEREAS, a committee was established to hold a public hearing on this proposal; and

WHEREAS, the committee consisted of Chris Dawkins, Community Representative selected by Council District 2 and Homer Garcia III, Assistant Director of the Parks and Recreation Department; and

WHEREAS, notice of the public hearing was advertised twice in the San Antonio Express-News and The Rivard Report; and

WHEREAS, it was also posted on the City of San Antonio Parks and Recreation website and a media release was distributed. Direct notification was mailed to one hundred twenty (120) residents and businesses within a two hundred (200) foot radius of this public park; and

WHEREAS, the Department received three (3) notices in favor of the proposed naming and none in opposition by mail; and

WHEREAS, the public hearing was held on Tuesday, February 26, 2019, at 6:30 p.m. at the Sinclair Elementary Cafeteria; and

WHEREAS, ten (10) members of the public attended the public hearing and none were in opposition; and

WHEREAS, after public input was received on the proposed name, the committee concurred to recommend to the City Council that the naming of the lake at Milam Tealer Park located at 5640 Lakefront Drive be named Lake Verda; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council of the City of San Antonio hereby adopts the name "Lake Verda" for the lake located in Milam Tealer Park as recommended by the convened naming committee.


SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
