The City Council convened in a Regular Meeting on Thursday, September 12, 2019 am. Interim Deputy City Clerk Tina Flores took the Roll Call noting a quorum with the following Councilmembers present:

- 1. The Invocation was delivered by Pastor Larry J. Thompson, True Vision Church, guest of Councilmember Jada Andrews-Sullivan, District 2.
- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- **3.** Approval of Minutes from the City Council Regular Meetings of August 7 8, 2019.

Councilmember Treviño moved to approve the Minutes of the City Council Regular Meetings of August 7-8, 2019. Councilmember Andrews-Sullivan seconded the motion. The motion to approve prevailed by the following vote:

CONSENT AGENDA ITEMS

Items 26 and 34 were pulled for Individual Consideration. Councilmember Treviño moved to approve the remaining Consent Agenda Items. Councilmember Courage seconded the motion.

Mayor Nirenberg called upon the citizens registered to speak.

Maggie Thompson Riverwalk Association Executive Director spoke in favor of Item 31 Levying an Assessment Rate for FY 2020 at \$0.15 per \$100 value of real property in the Downtown Public Improvement District (PID) and \$0.09 per \$100 value of residential condominiums and approving the FY 2020 Service and Assessment Plan for the Downtown PID. She added that the Riverwalk was the number one tourist attraction and approximately 13 million tourists visit the Riverwalk generating approximately \$3.5 billion annually.

Dave Krupinski Chief Operating Officer, Visit SA spoke in favor of Item 31. He noted that the Mission of Visit SA was to bring tourist to San Antonio. He mentioned the importance of the Centro Ambassador Program and described that were responsible for cleaning the Downtown area and greeting tourist.

Gabrielle Thompson Haven for Hope Representative spoke in favor of Item 31. She described the barriers that homeless people experience such as lack of transportation, no identification, addiction, and mental health challenges. She stated that the Program helps people find full-time employment and provides job skills training, housing, and provides meals.

Marylou Garza spoke in favor of Item 31. She noted the positive impact that the Cento Ambassadors provide to the Downtown area. She added that the Centro Ambassadors clean and maintain the plants to improve the appearance of downtown.

Nita Shaver spoke in favor of Item 31 adding the she and her spouse have resided downtown for eight years. She added that downtown was a vibrant place of people to live and work. She noted that the Centro Ambassadors lead the way to serve San Antonio with kindness and compassion daily. She commended the ambassadors for greeting visitors and directing them to their destination.

Colleen Wagonspeak Representative of Northside Neighborhoods for Organized Development spoke in opposition of Item 27. She noted that the Clear Channel Billboard Proposal was not a public transparent process. She added that the Sign Ordinance Committee had not been consulted by Clear Channel regarding their proposal. Lastly, she suggested that Item 31 should be postponed until after the Sign Ordinance was reviewed in 2020.

June Kachtik Board Chair of the Executive Committee of Scenic San Antonio spoke in opposition of Item 27. She noted that the UDC was scheduled for review in 2020 and should include Item 27 at that time. She suggested a process to determine which signs will be taken down by Clear Channel.

Jack M. Finger spoke in opposition of Items 27, 34, and 37. He noted that Digital Billboards along the highway was dangerous because of the bright flashing images illuminating on the billboard. He added that he was against the Dreamers Act and the Promise Act of 2019. He did not agree with the permanent pathway to citizenship.

Councilmember Viagran spoke in favor of Items 19A and 19B amending an agreement for construction of the Brooks City Base South New Braunfels Ave. She added that this item was part of the approved Bond Program and allows for connectivity on the Brooks Campus.

Councilmember Pelaez spoke in favor of Item 39 naming a new park to Dan Markson Park adjacent to Maverick Creek in the area of Babcock and West Hausman Road. He added that the neighborhood donated the land to the City for the purpose of the new park. Councilmember Pelaez showed a short video regarding the new park. He noted that the Dan Markson Park was the first park in San Antonio designed for Special Needs Children and their families. He added that Dan Markson was filled with passion, love, and consideration. He stated that Dan Markson touched the lives of many and passed away too soon.

Former City Councilmember Debra Guerrero stated that she had the pleasure of working under Mr. Markson's visionary leadership. She noted that he helped develop the Brooks Air Force Base area when nothing existed in the area. She added that Mr. Markson was a visionary and a humble man and would be proud of the proposed special needs park for children.

Mayor Nirenberg thanked the Maverick Neighborhood Association for donating the land for the park.

Councilmember Treviño recognized Matt Brown the new Centro CEO and welcomed him to San Antonio. He also recognized Maria whom was a Centro Ambassador that greets tourist downtown. He asked Maria to stand and asked for a round of applause.

Councilmember Perry recognized Mr. Markson and noted his personal touch to make things happen. He added that Mr. Markson had a passion for improving San Antonio and was proud of the Special Needs Park being named after him.

Councilmember Rocha Garcia spoke in favor of Item 28 appointing Athalie D. Malone to the VIA Metropolitan Transit Authority Board of Trustees. She added that Ms. Malone has a desire to be the voice for individuals with disabilities and has demonstrated perseverance in obtaining her goals to serve the community. She noted that Ms. Malone service on the board broadens the diversity and leadership of the board.

Athalie Malone thanked the Mayor and Council for appointing her to the VIA Board. She added that disability did not mean that you cannot do anything; disability means they just do it different. She noted that October was Disability Awareness Month and invited that Mayor and Council to participate in the many events around the city.

Mayor Nirenberg thanked Ms. Malone for her service on the Disability Advisory Commission and the VIA Board of Trustees. He added that appointing Ms. Malone to the VIA Board has been the most important VIA Trustee Appointee the Council has ever made for the City of San Antonio.

Patti Zaiontz, President of the San Antonio Conservation Society provided Written Testimony regarding Item 27. The Conservation Society welcomes the opportunity to reduce the number of billboards. She added that Clear Channel committed to remove one-fourth of the billboards in exchange for allowing Clear Channel to double-side existing digital billboards. She suggested that City Staff compare San Antonio billboards policy to other cities in Texas. She also suggested the City to establish a plan and

prioritize billboards to be removed targeting first Historic Districts, Urban, and Scenic Corridors. Lastly, she requested a reliable system for monitoring the illumination given the Dark Sky mandate for Joint Base San Antonio.

Robert A Shearer submitted Written Testimony regarding Item 31 on the Consent Agenda. He was in support of the Downtown Public Improvement District (PID) but was concerned about the increase in the assessment rate and the increase in property values. He asked for temporary relief or a partial waiver due to the construction on the San Pedro Creek which has caused street closures and blocked access to Commerce Street.

City Manager Walsh noted that the Mayor and Council was being asked to approve the Proposed Budget that was presented during 14 community meetings, several budget work sessions, and two budget amendment sessions. He noted that as required by law, he has prepared a balanced spending plan for FY 2021 that's consistent with our two-year balanced budget strategy. He added that there is no increase to the City's Property Tax Rate. City Manager Walsh reiterated the City Council's five key areas of Strong Families and Children, Police, Affordable Housing, Streets and Sidewalks, and Property Tax Relief. He added that the proposed budget encompasses those priorities as requested.

Mayor Nirenberg noted that the Budget Adoption Process was an orchestrated meeting and summarized the process. He added that Public Comment would be taken first followed by City Council comments on the budget. He added that at that point, the procedural votes on the budget will occur. He noted a new process whereby, City Councilmembers will stay seated and when the time comes to recuse themselves they will place their recusal sign in front of them and they will not participate in the discussion and they will not leave the dais. The Councilmember will remove their recusal sign when they are back in full discussion.

Mayor Nirenberg called upon the individuals registered to speak:

Dr. Paul Ruiz, National Institute of Mexican American History of Civil Rights Board President noted their goal was to collaborate with school systems, local universities, business, and civic organizations. He added that the purpose of the Institute was to teach, educate, and record the significant contributions of Mexican Americans made to their community, state, and nation regarding the development of Civil Rights and the fair treatment of all people.

Dr. Gloria Rodriguez National Institute of Mexican American History of Civil Rights Board Vice Chair stated that there are over 160 Civil Rights Centers for African Americans in the Nation but not one for Mexican Americans. She added that the African American Community should be applauded for their great job of documenting their Civil Rights. She asked for City Council support for the Planning Grant to establish the first-ever Civil Rights Center in San Antonio.

Dr. Ezequiel Pena, Director of the Center for Mexican American Studies and Research at Our Lady of the Lake University (OLLU) read excerpts from a letter of support from Dr. Diane Melby, President of OLLU. He added that San Antonio was central to the story of Civil Rights for the Latina and Latino community and welcomed a partnership with the Institute.

Olga Garza Kaufman stated that she grew up in the Rio Grande Valley in a farm worker family and went to segregated Mexican school and never had access to the history of the Mexican Americans in Texas. She added that she knew the History of Mexico because her Mother was a well-read woman and she believed in education and taught her how to read Spanish when she was 4 years old. She urged the Council to fund the Institute at \$250,000 to allow children to have the resources needed to research Mexican American History.

Leo Gomez, CEO of Brooks Development Authority thanked the Council for the tribute to Dan Markson. He recognized the relatively smooth budget process this year and commended City Staff for their teamwork. He encouraged City Council to celebrate Happy New Fiscal Year on October 1st. He thanked Councilmember Viagran for her commitment to add a new Police Substation in District 3.

Jack M. Finger noted that it was budget season and there was not enough money to fund all the projects. He noted that he did not agree with the funding for the Second Change Initiative, the Girls Empowerment Summit, Funding for a Cricket Field, or funding for the Mexican American Civil Rights Institute.
