## AN ORDINANCE 2014 - 06 - 12 - 0425

AUTHORIZING THE REALLOCATION OF FUNDS IN THE AMOUNT OF \$200,000.00 FROM THE DISTRICT 1 NEIGHBORHOOD ACCESS AND MOBILITY PROGRAM FUNDS TO THE D1/D5 AUSTIN 1 QUIET ZONE PROJECT AND AMENDING THE FY 2014-2019 CAPITAL IMPROVEMENT PROGRAM BUDGET.

WHEREAS, the Districts 1 and 5 Quiet Zone project along the Austin 1 rail line provides for the construction of a 0.53 mile long quiet zone along seven crossings on the Austin 1 Union Pacific Railroad (UPRR) line from Fredericksburg Road in Council District 1 to Delgado Street in Council District 5; and

WHEREAS, Quiet Zones are governed by rules of the Federal Railroad Administration (FRA) which requires that the average risk of vehicle accidents within the Quiet Zone be reduced by implementing safety measures such as concrete medians, conversion of crossings from two-way to one-way traffic, signage and pavement markings, installation of quad gates and crossing closures; and

WHEREAS, this project will bridge two quiet zones that currently exist along the Austin 1 line allowing for a quiet zone 2.41 miles long from Martin Street (Haven-for Hope Quiet Zone) in the south direction and Hollywood Street (District 1 South Quiet Zone) in the north direction.

WHEREAS, this Ordinance will authorize the reallocation of funds in the amount of \$200,000.00 from the District 1 Neighborhood Access and Mobility Program Funds to the Districts 1 and 5 Quiet Zone project along the Austin 1 rail line; and

WHEREAS, if these are approved by the FRA, they will establish this area as a Quiet Zone whereby trains will not routinely sound their horns, however, locomotive crews may still retain the option to use the train horn in the event of emergencies, NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The reallocation of funds in the amount of \$200,000.00 from the District 1 Neighborhood Access and Mobility Program Funds to the D1/D5 Austin 1 Quiet Zone Project is hereby authorized.

**SECTION 2.** The following financial adjustments are hereby approved:

a) The budget in SAP Fund 40099000, Other Capital Projects, SAP Project Definition 40-00453, UIW Medical School Connector Streets, shall be revised by decreasing

- SAP WBS Element 40-00453-01-02-01 entitled City Contract, SAP GL account 5201170, by the amount of \$200,000.00.
- b) The budget in SAP Fund 40099000, Other Capital Projects, SAP Project Definition 40-00453, UIW Medical School Connector Streets, shall be **revised by decreasing** SAP WBS element 40-00453-90-14-01 entitled Transfer from IO# 390000001723, SAP GL account 6101100, by the amount of \$200,000.00.
- c) The amount of \$200,000.00 is **reverted** in SAP Fund 11001000, General Fund, SAP Internal Order # 390000001723, SAP GL account 6102100 Interfund Transfer out entitled Transfer to 40-00453-90-14-01. The amount of \$200,000.00 is authorized to be transferred from SAP Fund 40099000.
- d) The amount of \$200,000.00 is appropriated in SAP Fund 11001000, General Fund, SAP Internal Order # 390000001723, SAP GL account 6102100 Interfund Transfer out entitled Transfer to 23-01410-90-14-01. The amount of \$200,000.00 is authorized to be transferred to SAP Fund 40099000.
- e) The budget in SAP Fund 40099000, Other Capital Projects, SAP Project Definition 23-01410, D1D5 Austin 1 Quiet Zone, shall be revised by increasing SAP WBS element 23-01410-90-14-01 entitled Transfer from IO# 390000001723, SAP GL account 6101100 Interfund Transfer In, by the amount \$200,000.00.
- f) The amount up to \$50,000.00 is appropriated in SAP Fund 40099000, Other Capital Projects, SAP Project Definition 23-01410, D1D5 Austin 1 Quiet Zone, SAP WBS Element 23-01410-01-02, entitled Design Costs, SAP GL Account 5201170.
- g) The amount up to \$150,000.00 is appropriated in SAP Fund 40099000, Other Capital Projects, SAP Project Definition 23-01410, D1D5 Austin 1 Quiet Zone, SAP WBS Element 23-01410-05-02-01, entitled City Construction, SAP GL Account 5201140.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
