

AN ORDINANCE

AUTHORIZING THE EXECUTION OF AN AGREEMENT FOR THE JOINT USE AND CO-LOCATION OF THE DISTRICT 6 ALICIA TREVIÑO LÓPEZ SENIOR ONE STOP CENTER AND DISTRICT 7 DORIS GRIFFIN SENIOR ONE STOP CENTER WITH WELLMED CHARITABLE FOUNDATION FOR A TERM BEGINNING OCTOBER 1, 2019 THROUGH SEPTEMBER 30, 2025 AND AN OPTION TO RENEW FOR ONE 2-YEAR TERM.

WHEREAS, the City is committed to providing San Antonio seniors comprehensive services that enhance their social, psychological, and physiological well-being, and offers a variety of services within City owned and leased facilities to senior citizens, ages 60 and older; and

WHEREAS, on December 1, 2010, City Council approved a contract between the City and WellMed Charitable Foundation (WellMed) for the District 6 Alicia Treviño López Senior One Stop Center pursuant to Ordinance No. 2010-10-14-0895, and again on August 8, 2013 for the District 7 Doris Griffin Senior One Stop Center pursuant to Ordinance No. 2013-08-08-0525, to co-locate and jointly provide senior services; and

WHEREAS, the District 6 agreement terminates on September 30, 2019 and the District 7 agreement will terminate on September 30, 2020; however, the Parties desire to enter into one agreement to jointly operate and maintain both Centers, which will supersede the remainder of the District 7 agreement; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The execution of an agreement for the Joint Use and Co-Location of the District 6 Alicia Treviño López Senior One Stop Center and the District 7 Doris Griffin Senior One Stop Center (Centers) with WellMed Charitable Foundation (WellMed) for a term beginning October 1, 2019 through September 30, 2025, and an option to renew for one 2-year term, is approved. The agreement in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. Amendments up to 10% of the amount of this original Joint Use and Co-Location Agreement are approved.

SECTION 3. Funding in the amount of \$468,677.00 for this ordinance is available as part of the Fiscal Year 2020 budget in the combined amounts of \$270,040.00 and \$198,637.00 from General Ledger 5202020 and Fund 11001000, and Internal Order Numbers 3806020601 and 3806020701, respectively. Payment not to exceed the budgeted amounts is authorized to WellMed for the Joint Use and Co-Location of the Centers.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
