A. Invoice 2: \$152,378.85

For a total of \$152,378.85 in allowable reimbursable expenses within the approved Development Agreement for public improvements for the Red Berry Estate Project.

- Consideration and action regarding approval of a payment schedule of eligible reimbursements for the Sunset Station and St. Paul Square project for the remainder of the fiscal year to September 30, 2020. The Development Agreement provides for a total of up to \$1,325,000 in TIRZ funds for the following public improvements: Courtyard; SPS District; Wayfinding; Espee Front Plaza; and Espee Pavilion.
- 7. Consideration and Action Regarding Approval of an invoice for the Alamo Street Lighting King William Association (KWA) Pedestrian Project for the following:

A. Invoice 1: \$160,000

For a total of \$160,000 in allowable reimbursable expenses within the approved Development Agreement for public improvements along the South Alamo Street.

8. Consideration and action regarding approval of a payment schedule of eligible reimbursements for the Alamo Inn & Suites project for the remainder of the fiscal year to September 30, 2020. The Development Agreement provides for a total of up to \$130,000 in TIRZ funds for the following public improvements: Related Archaeological work, Land Record fees, Engineering (Structural/GEO/etc.), Architecture work and Roofing improvements.

9. Consideration and action to approve an amended and restated Development Agreement with MLK Garden Homes, LLC to amend the scope and terms of the project to include land acquisition and an additional ask of up to \$150,000.
