These modified standards shall remain in place until further notice or until the state disaster declaration expires or is otherwise terminated by the Texas Governor.

D.	20-5393	Legal issues related to litigation involving the City pursuant to Texas Government Code Section 551.071 (consultation with attorney).
E.	<u>20-5394</u>	Discuss legal issues relating to COVID-19 preparedness pursuant to Texas Government Code Section 551.071 (consultation with attorney].
