- 1. Protest and appeals of questions from the written examination for the position of Police Detective Investigator Exam administered on May 14, 2020.
- 2. Pending the outcome of the Detective Investigator Appeals Hearing, Notice and appropriate action regarding the approval of the eligibility list for the position of Police Detective Investigator created from the Police Detective Investigator examination administered on May 14, 2020. This eligibility list will be valid for one (1) year after the date on which the written examination was given or until the list is exhausted. If changes are made to the examination as a result of the Appeals Hearing, this item will be tabled and an amended eligibility list will be certified at a subsequent San Antonio Fire Fighters' and Police Officers' Civil Service Commission Meeting.
- 3. Notice and appropriate action regarding the approval of the eligibility list for the position of Fire Captain created from examination administered on March 13, 2020. This eligibility list will remain in existence for one year beginning on the first day of the month following the month the written examination was given or until the list is exhausted.

- 4. Notice and appropriate action regarding the approval of the eligibility list for the position of Probationary Firefighter created from Probationary Firefighter Examination administered on March 13, 2020. This eligibility list will be valid for a period of one (1) year from the effective date or until the list is exhausted.
- 5. Notice and appropriate action regarding the approval to administer a Fire Engineer examination. The two-hour written examination will be given at 9:00 AM on July 2, 2020, at the Henry B. Gonzalez Convention Center, 900 East Market St. in the Hemisfair Ballroom. The eligibility list resulting from this exam will remain in existence for one year beginning on the first day of the month following the month the written examination was given or until the list is exhausted.
- 6. Notice of a B Fire Lieutenant Examination. This two hour written examination will be administered at 9:00 AM on August 10, 2020 for Fire Engineer Eric Elizondo who was on military leave on February 21, 2020 when the original exam was administered. The exam will be held at the San Antonio Fire Training Academy, 300 S. Callaghan Road, San Antonio, Texas 78227.
- 7. Notice and appropriate action regarding the approval to administer a Police Captain examination which will consist of a written examination and a video recorded assessment center. The two hour written examination will be given at 9:00 AM on October 1, 2020, at the Henry B. Gonzalez Convention Center, 900 East Market Street, Room 225. Information regarding the date, time, and location of the video recorded assessment center will be announced in the Daily Bulletin at a later date. The eligibility list resulting from this exam will remain in existence for 18 months from the date of certification by the Commission, or until the list is exhausted.
- 8. Notice and appropriate action regarding the approval to administer a Police Lieutenant examination which will consist of a written examination and a video recorded assessment center. The two hour written examination will be given at 9:00 AM on November 2, 2020, at the Henry B. Gonzalez Convention Center, 900 East Market Street, Room 221. Information regarding the date, time, and location of the video recorded assessment center will be announced in the Daily Bulletin at a later date. The eligibility list resulting from this exam will remain in existence for 18 months from the date of certification by the Commission, or until the list is exhausted.
