- 3. Leave a voice message of a maximum two minutes by dialing (210) 207-4686 by 12 Noon. Your message will be played during the meeting. Please include your full name, home or work address, and item number.**
- 4. Sign up to give your comments live during the meeting by leaving your name, telephone number, and item number on which you would like to speak on at (210) 207-4686 by 12 Noon. City staff will call you when your item is up for discussion but cannot guarantee a specific time after 4 P.M. Once you join the call, you will be given two minutes to provide your comments.**
