3. Leave a voice message of a maximum two minutes by dialing (210) 206-8368 (VENT) by 4pm the day before the meeting. Your message will be played during the meeting. Please include your full name, home or work address, item # and/or address of the request.

4. Sign up to give your comments live during the meeting by leaving your name, telephone number, item # on which you would like to speak on at (210) 206-8368 (VENT) by 4pm the day before the meeting. City staff will call you when your item is up for discuss but cannot guarantee a specific time. Once you join the call, you will be given two minutes to provide your comments; however, an owner or owner's representative will have unlimited time.
