- 3. Leave a voice message of a maximum two minutes by dialing 210-207-2595. Your message will be played during the meeting. Please include your full name, home or work address and item #, if applicable, you are speaking about.
- 4. Sign up to give your comments live during the meeting by leaving your name, telephone number, and item on which you would like to speak on at 210-207-2595. Library staff will call you when your item is up for discussion. We cannot guarantee a specific time after 4:30 pm and will make only one attempt to reach you during the meeting. Once you join the call, you will be given two minutes to provide your comments.
