These comments will be read at the time the agenda item is heard, as requested. Please include your full name, home or work address, and item number (if applicable). General comments unrelated to specific items will be read during the Public Comments section of the agenda.

2. Drop off or mail a written statement to the Parks and Recreation Department Directors Office by 1:00 PM on August 24, 2020. Mail must be submitted to: City of San Antonio, Parks and Recreation Department, Attn: Ryan Evans, Executive Assistant, PO Box 839966, San Antonio, TX 78283-3966. Comments may also be hand delivered to the Parks and Recreation Director's Office at 114 West Commerce Street. The written statement may be up to 300 words. Please include your full name, home or work address and item number. These comments will be read at the time the item is heard or during the general Public Comments section of the agenda.

3. Leave a voice mail message of a maximum of two (2) minutes by dialing (210) 207-6101 by 1:00 PM on August 24, 2020. Your message will be played during the meeting. Please include your full name, home or work address, and item number (if applicable).

4. Sign up to give your comments live during the meeting by leaving your name, telephone number, and item number on which you would like to speak on at (210) 207-6101 by 1:00 PM on August 24, 2020. City staff will contact you when your item is up for discussion but cannot guarantee a specific time after 6:00 PM. Once you join the call, you will be given two (2) minutes to provide your comments.
