- 2. Drop-off a written statement at 1901 S. Alamo, San Antonio, TX 78204 by 4pm the day before the meeting. The written statement can be up to 300 words. Please include your full name, home or work address, item # and/or address of the request. These will be read at the time the item is heard.**
- 3. Leave a voice message of a maximum two minutes by dialing (210) 206-8368 (VENT) by 4pm the day before the meeting. Your message will be played during the meeting. Please include your full name, home or work address, item # and/or address of the request.**
- 4. Sign up to give your comments live during the meeting by leaving your name, telephone number, item # on which you would like to speak on at (210) 206-8368 (VENT) by 4pm the day before the meeting. City staff will call you when your item is up for discuss but cannot guarantee a specific time.**

Once you join the call, you will be given two minutes to provide your comments; however, an owner or owner's representative will have unlimited time.

***Note Comments may be submitted in Spanish. Written comments, voicemails and requests to make comments during the meeting live must be received by 10am the day before the meeting to give time for translation.**
