Written statements can be up to 300 words. Please include your full name, email address, phone number, and the item number you wish to speak on if applicable. These will be read at the time the item is heard. Comments without an item number will be read during the Public Comment period at the beginning of the meeting.

**2. Leave a voice message by dialing (210) 207-4686 by 12 P.M. the day of the meeting.**

Your message can be up to three minutes long and will be played during the meeting. Please include your full name, home or work address, and the item number you wish to speak on, if applicable.

**3. Give your comments live during the meeting. Sign up by calling (210) 207-4686 by 12 P.M. the day of the meeting.**

Please include your full name, phone number to which to call you during the session, and the item number on which you would like to speak. City staff will call you when your item is up for discussion but cannot guarantee a specific time after 4 P.M. Once you join the call, you will be given three minutes to provide your comments.

**Comments in languages other than English are welcome. All written comments must be received by 4 P.M the day before the meeting. Voicemails or sign-ups to speak must be received by 12 P.M the day of the meeting.**
