1. Submit written comments, up to 300 words, along with name and address, by emailing them to sustainability@sanantonio.gov by 12:00 p.m. on the day of the meeting. Comments will be read into the record during the designated time on the agenda. Only the first 300 words will be read and entered into the record.
2. Leave a voice mail message of a maximum of two (2) minutes by dialing (210) 207-6323 by 12:00 p.m. on the day of the meeting. Your message will be played during the meeting. Please include your full name, home or work address, and item number (if applicable).
3. Sign up to give your comments live during the meeting by leaving your name, telephone number, item number (if applicable) on which you would like to speak on at 210-207-6323 or sustainability@sanantonio.gov by 12:00 pm the day of the meeting. City staff will call you when your item is up for discussion but cannot guarantee a specific time after 4:00 p.m. Once you join the call, you will be given two minutes to provide your comments.
