STATE OF TEXAS COUNTY OF BEXAR CITY OF SAN ANTONIO

A BUDGET WORK SESSION AND REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF SAN ANTONIO WERE HELD IN THE MUNICIPAL PLAZA BUILDING, WEDNESDAY, SEPTEMBER 4, 2013, AND THURSDAY, SEPTEMBER 5, 2013, RESPECTIVELY.

The San Antonio City Council convened in a Budget Work Session at 2:00 pm Wednesday, **September 4, 2013,** Municipal Plaza Building, with the following Councilmembers present: Bernal, Taylor, Viagran, Saldaña, Gonzales, Lopez, Medina, Nirenberg, Chan, Soules, and Mayor Castro. **ABSENT:** None.

1. STAFF PRESENTATION AND POSSIBLE CITY COUNCIL ACTION ON POTENTIAL CITY COUNCIL AMENDMENTS TO THE FY 2014 PROPOSED BUDGET.

OFFICE OF HISTORIC PRESERVATION

Shanon Miller presented the FY 2014 Proposed Budget for the Office of Historic Preservation. She stated that the Strategic Historic Preservation Plan was adopted in 2009 and highlighted FY 2013 Accomplishments. These include the adoption of Citywide Historic District Design Guidelines by the City Council and 34 Landmark Designations. She outlined Public Education and Outreach Programs and highlighted the Students Together Achieving Revitalization (STAR) Program. She explained that STAR was a collaboration with the UTSA College of Architecture and the San Antonio College Department of Architecture to assist with the maintenance of Historic Homes.

Ms. Miller reported FY 2014 Programs and Initiatives which include a Historic Resources Survey and continued Public Education and Outreach. She stated that the FY 2014 Proposed Budget totaled \$1.03 million and that they were proposing to eliminate one vacant Volunteer Services Coordinator Position. She indicated that they would work to reduce the number of days required to review Master Development Plans (MDP) from 30 to 18 days. She noted that they would add two new fees: 1) MDP Review Fee of \$200; and 2) Plat Review Fee of \$175. She added that their priorities for FY 2014 were to support the World Heritage Nomination of the San Antonio Missions and conduct an Economic Impact Study.

Mayor Castro thanked staff for the presentation. He asked where San Antonio stands in terms of Historic Preservation. Ms. Miller replied that nationally, San Antonio has been as a leader in Historic Preservation but there are still some challenges. Mayor Castro asked of the focus on making other neighborhoods aware of the Historic Areas on the East and West Sides of the city. Ms. Miller stated that they were making progress and mentioned the West Side Cultural Resources Survey that was being conducted. Mayor Castro asked of the housing along the Mission Reach Corridor. Ms. Miller responded that much of the housing was located in the Mission Historic District and makes property owners eligible for incentives.

Councilmember Medina asked of education to homeowners regarding what they are allowed to change to their properties. Ms. Miller replied that they conduct a Realtor Continuing Education Training on an

20130905 1 of 41 LV/lys annual basis and work closely with the San Antonio Board of Realtors (SABOR) on same. She explained that if something was changed without the approval; the homeowner could request approval from the Historic and Design Review Commission (HDRC).

Councilmember Bernal commended staff for their work. He spoke of challenges with a project being stalled due to differing opinions and asked how staff was addressing same. Ms. Miller stated that they tried to be proactive and work with communities regarding the important historic and cultural assets in their neighborhoods. She spoke of their work with the San Antonio Conservation Society, Westside Preservation Group, and others that are interested in designating resources.

Councilmember Viagran asked of the two new fees proposed. Ms. Miller replied that the MDP Review and Plan Review Fees would be assessed for all Plans and Plats; not just those for Historic Properties. Councilmember Viagran thanked staff for their work and spoke of the importance of educating the community.

Councilmember Gonzales commended staff for their efforts on West Side Historic Preservation.

Councilmember Lopez spoke of the World Heritage Designation and asked of coordination with the Hemisfair Park Area Redevelopment Corporation (HPARC). Ms. Miller replied that they work closely with HPARC but noted that the since the area is on the National Registry; they work with other stakeholders such as the Texas Historical Commission. Councilmember Lopez stated that there were many moving parts to World Heritage Designation and asked of the timeline. Ms. Miller replied that she was not sure and that it was being managed by HPARC.

DEBT MANAGEMENT PLAN

Assistant City Manager Ben Gorzell presented the Debt Management Plan and outlined the types of debt issued by the city: 1) General Obligation Bonds; 2) Certificates of Obligation; 3) Tax Notes; and 4) Revenue Debt. He reported that the City Charter establishes limitations on General Obligation Debt supported by Ad Valorem Taxes not to exceed 10% of total assessed valuation. He provided an overview of the Outstanding Debt through September 30, 2013 noting that Outstanding Principal totaled \$2.4 billion. He outlined the Bond Ratings by Fitch, Moody's, and Standard & Poors. He reported that since April 2012, the City has completed five refunding transactions for interest cost savings resulting in total gross savings of \$39.9 million. He noted FY 2013 New Issuances and upcoming transactions to include the Airport Consolidated Car Rental Facility. He mentioned the multiple Debt Management Plans: 1) Ad Valorem; 2) Airport; 3) Convention Center; 4) Municipal Drainage Utility System; and 5) Other Transactions.

Mr. Gorzell outlined the Ad Valorem Debt Management Plan and mentioned that Key Variables include a 20-25 Year Fixed Rate Debt with Structuring. He highlighted the Actual and Potential Issuances from 1994 through 2022. He reported the proposed Tax Rate for FY 2014 of \$0.56569 and stated that the planned draw down from FY 2013 through FY 2028 would target a balance of \$25 to \$30 million. He noted that a positive performance over the Ad Valorem Debt Management Plan would be utilized to provide further flexibility.

Mayor Castro thanked staff for the presentation and asked how San Antonio compares to other Texas Cities in terms of Debt Management. Mr. Gorzell replied that he believed that San Antonio fared well in comparison and referenced the City's AAA General Obligation Bond Rating.

20130905 2 of 41 LV/lys Councilmember Nirenberg asked of San Antonio's Historic Grade over the last 10-15 years. Mrs. Sculley stated that the city was upgraded to AAA by Standard & Poors in 2008 and by the other two rating agencies in 2009. Mr. Gorzell added that prior to that; the city was in the AA Category and AA+ in the 1990's. Councilmember Nirenberg asked of a financial strategic plan. Mr. Gorzell stated that the Bond Rating Agencies looked at the Total Fund Balance as well as the Available Balance from year to year. He noted that they also look at the Budget Shortfall projected for the following year. Councilmember Nirenberg requested a financial outlook projected for 2015-2016 noting the great increase in Legacy Costs.

Councilmember Chan commended staff for their work and asked of the Fund Balance recommended by Moody's. Mr. Gorzell replied that they looked at a Total Fund Balance of 24% and an Available Balance of 15% of Total Revenues. Councilmember Chan asked of the issuance of Tax Notes. Mr. Gorzell responded that they review the useful life of projects for alignment and then use Tax Notes to create capacity.

Councilmember Lopez asked of the projections regarding the streets that the Texas Department of Transportation (TxDOT) may require cities to oversee. Mr. Gorzell replied that they had not run any scenarios related to TxDOT. Mrs. Sculley added that they were aware of the estimated costs but had not included them in the Budget Projections. Councilmember Lopez spoke of the importance of completing Bond Programs on time and within budget.

Mrs. Sculley provided the City Council with budget information requested at previous City Council Budget Work Sessions. She also provided a list of Potential Amendments for the FY 2014 Operating and Capital Budget.

Xavier Urrutia presented an overview of the proposed \$1 per month dedicated Parks Fee to be added to the Environmental Fee. He stated that the fee would be collected within the CPS Energy Monthly Bill and would be used for Sanitation, Mowing, Tree Trimming and Maintenance. He reported that the fee would generate \$6.6 million in revenue and that \$240,000 of that amount would used to pay for CPS Billing and Collection Services. He noted that funding of current eligible General Fund Parks Environmental Activities allows for: 1) \$1.9 million to reinstate Parks Service Modification Reductions included in the FY 2014 Proposed Budget; 2) \$545,000 to reduce Proposed Park Revenue Increases; 3) \$1.45 million in Deferred Maintenance Projects currently included in the \$5 million Deferred Maintenance Program; and 4) \$2.5 million for Parks Deferred Maintenance, Park Upgrades, Community Center Renovations, and SPARK Projects.

Mr. Urrutia explained that if implemented, they would reinstate the Swimming Pool Hours and Open Play Center Hours of Operation that had been proposed for reduction. Additionally, they would eliminate the Swim Pass Fee, Community Center Membership Fee, and new Boxing Participation Fee, as well as reduce the increase to Summer Youth Program Fees. He stated that utilizing \$1.45 million for Deferred Maintenance Projects would provide capacity in the Capital Improvement Plan. He outlined the recurring maintenance and general upgrades that would be funded and added that SPARK Projects would be implemented in Districts 5, 9, and 10.

Mayor Castro thanked staff for the presentation. He stated that he was supportive of dedicated revenue under two circumstances: 1) Must be distributed citywide; and 2) All funds generated should not be shifted to replace General Fund Projects. Mayor Castro asked if the Crisis Response Team (CRT) and Library Hours that had been proposed for reduction were being fully restored through the Amendments

presented today. Mrs. Sculley confirmed that the 10 Civilian Positions for the CRT and the reduced Library Hours were being fully restored. Mayor Castro asked of the Cloud Academy. Mrs. Sculley replied that it was a Workforce Development request through Project Quest to partner with the Cloud Academy, a sub-group of Rackspace. Mayor Castro expressed support for the Amendments presented.

Councilmember Bernal expressed support for the dedicated Parks Fee of \$1 per month noting that he was pleased that the Open Play Centers and Swimming Pools would remain open. He spoke of the importance of the CRT and stated that he was pleased that the positions related to same were being reinstated.

Councilmember Nirenberg stated that the city should develop a long-term solution to Parks Issues such as Deferred Maintenance and Parks Programming. He noted that he was pleased that the Parks Programming and Hours proposed for reduction would be restored. He asked that staff review the \$1 fee per month to see if it was a fixed amount or could be adjusted.

Councilmember Soules stated that he was supportive of having voters decide if an Enterprise Fund should be created for Parks Maintenance through the 1/8-cent Sales Tax currently being used for Aquifer Protection. He expressed concern with using a portion of the Dedicated Parks Fee for other General Fund Projects.

Councilmember Viagran expressed support for the Dedicated Monthly Parks Fee and stated that she was pleased with the reinstatement of Open Play Centers, Libraries and CRT Positions.

Councilmember Lopez spoke of the great investment and leveraging of funds through SPARK Parks and asked if any funding had been restored to the CIMS Department. Mrs. Sculley replied that they had not restored any CIMS Positions but could review same at the direction of the City Council. Councilmember Lopez stated that it was important for CIMS to have sufficient staff to ensure that the Bond Program is completed on time and within budget.

Councilmember Gonzales asked of the use of the \$1 Dedicated Parks Fee. Mrs. Sculley replied that it would be used to fund a portion of the services that Parks is providing today, restore the proposed reductions, and expand Park Improvements to free up General Funds. Councilmember Gonzales expressed support for restoring Library and Swimming Pools Hours.

Councilmember Chan expressed concern that the \$1 Dedicated Parks Monthly Fee would not be used solely for Parks and recommended a Parks Monthly Fee of \$0.73.

Councilmember Nirenberg stated that Proposition 1 Aquifer Protection Program was very important for the community and cautioned the use of these dedicated funds toward Parks Programming.

Councilmember Taylor expressed support for the Budget Amendments presented by staff.

Councilmember Saldaña spoke of the many challenges in the FY 2014 Budget and expressed support for the \$1 Monthly Parks Fee. He requested the curriculum for the Cloud Academy.

Mayor Castro thanked staff for the presentation.

Mayor Castro reconvened the meeting at 6:00 pm at which time it was noted that the City Council had been briefed in Executive Session but took no action.

The City Clerk read the caption for Item 2:

Item 2. PUBLIC HEARINGS ON THE CITY'S 2013 PROPOSED AD VALOREM TAX RATE FOR THE FY 2014 BUDGET AND THE FY 2014 PROPOSED BUDGET.

Maria Villagomez stated that two Public Hearings on the City's Proposed Property Tax Rate were required by State Law. She reported that the FY 2014 Proposed Budget was presented to the City Council on August 8, 2013 and was balanced. She noted that there was no City Property Tax Rate Increase and that funding for sidewalks and drainage would be increased. She stated that the City's Consolidated Budget is 1% less than FY 2013 and that the FY 2014 General Fund Proposed Budget was less than 1% higher than FY 2013. She highlighted the \$13 million in Budget Reductions which include the elimination of 279 Civilian Positions. She mentioned that \$6.2 million was added for Service Improvements and that the FY 2014 General Fund Budget totaled \$988,890,690.

Ms. Villagomez reported that the City Current Property Tax Rate was 56.569 cents per \$100 taxable valuation and that Property Values had increased by 4.68%. She stated that the city continues its commitment to provide tax relief to Seniors and Disabled Property Owners. She spoke of the five community budget meetings that were held in August and noted that the Budget would be adopted on September 12, 2013.

Mayor Castro stated, "The second Combined FY 2014 Budget and 2013 Tax Rate Public Hearing is hereby opened. All persons wishing to express their views may do so. Comments must be limited to matters regarding the Budget, the Tax Rate, or both. Mention of any other matter or subject may result in termination of the speaker's presentation."

Mayor Castro called upon the individuals registered to speak.

Kelly Plessala expressed concern with the funding allocated to the Brooks Animal Care Facility noting that it had been approved as a temporary facility. She stated that the animals at the Brooks Facility were unseen and that too many had been killed.

Sofia Molinar-Kienlen addressed the City Council in opposition to the increase in Parks and Recreation Dance Class and Music Lesson Fees. She highlighted the benefits of music and dance lessons.

Debra Harlach gave her time to Kelly Plessala. Ms. Plessala expressed concern with the many animals being killed at the Brooks Animal Care Facility.

Stacey Doerschug expressed concern with the funding allocated to the Brooks Animal Care Facility. She noted that there was no public signage or access to the facility.

Andrea Kienlen stated that she was 9 years-old and takes Dance and Piano Lessons through the Parks and Recreation Department. She asked the City Council not to increase the participation fees for same.

Tina Kauppila addressed the City Council in opposition to the funding allocated to the Brooks Animal Care Facility. She spoke of concerns regarding the treatment and care of the animals.

Elva Trevino requested \$800,000 in funding for Lerma's Nightclub and spoke of the repairs that were needed. She noted that the residents of the West Side of San Antonio deserved to have the building preserved.

Pajara Canestaro addressed the City Council and requested funding for Lerma's Nightclub. She stated that it was a Historic Landmark for the area.

Susana Segura, Graciela Sanchez, and Patrick Pineda representing the Esperanza Peace and Justice Center addressed the City Council in support of funding for Lerma's Nightclub. Ms. Sanchez requested that funding be restored for Parks, Libraries and the Arts.

Gloria Ramirez spoke in support of funding for Lerma's Nightclub and requested that funding be maintained for the Library System.

Melissa Rodriguez addressed the City Council in support of funding for Lerma's Nightclub. She stated that it was important to preserve the culture and history of the facility.

Imelda Arismendez also spoke in support of funding for Lerma's Nightclub. She stated that it represented the Working Class and believed it was historically important for the area.

Stacey Bryant expressed opposition to the proposed increase in fees for Parks and Recreation Dance Classes. She stated that she was a single mom and would not be able to afford to pay for the classes for her daughter.

Anzleigh Bryant stated that she was 8-years-old and spoke against increases to parks and recreation fees. She noted that her mom would not be able to afford to send her to dance classes if the fees were increased.

Jack M. Finger expressed concern with the negative impact on the budget if the Non-Discrimination Ordinance is approved by the City Council.

Mayor Castro thanked the individuals that spoke and stated, "The City Council will vote on the City of San Antonio Property Tax Rate for Tax Year 2013 at its meeting on Thursday, September 12, 2013, which will begin at 9:00 am and will be held in the City Council Chamber, 114 W. Commerce Street. Having heard all comments from the citizens wishing to be heard, the second Combined FY 2014 Budget and 2013 Tax Rate Public Hearing is hereby closed."

Item 4. AN ORDINANCE ADOPTING A CONSOLIDATED NON-DISCRIMINATION POLICY WITH EXPANDED PROTECTION INCLUDING SEXUAL ORIENTATION, GENDER IDENTITY AND VETERAN STATUS AND PROVIDING FOR PENALTIES.

Michael Bernard presented information regarding the proposed Non-Discrimination Ordinance (NDO). He explained that Councilmember Bernal had circulated a Discrimination-Free Workplace Initiative in a Council Consideration Request (CCR) in May. The Governance Committee considered the request on May 21, 2013 and requested a B Session Presentation. He stated that the City's current Non-Discrimination Provisions appear in various sections of the City Code, Ordinances, and Policies which include: City Employment, City Board and Commission Appointments, Public Accommodations, Housing, and City Contracting & Subcontracting. He noted proposed goals of the NDO which would consolidate various Non-Discrimination Policies into one accessible chapter in the City Code, Chapter 2, Article X. Additionally, it would expand protections to include Sexual Orientation, Gender Identity, and Veteran Status. He indicated that it would require most City Contracts to include contractual assurances for policy compliance by vendors and contractors.

Mr. Bernard stated that, "Nothing in the NDO would be construed as supporting or advocating any particular lifestyle or religious view. To the contrary, it is the intention of the Ordinance that all persons be treated fairly and equally and it is the express intent of the Ordinance to guarantee to all of our citizens fair and equal treatment under the law." He highlighted the Proposed NDO Policy which prohibits discrimination against persons on the basis of Race, Color, Religion, National Origin, Sex, Sexual Orientation, Gender Identity, Veteran Status, Age, or Disability in the areas covered by the Ordinance, unless exempted by State or Federal Law. He added that it allows a religious entity or educational institution owned in whole or substantial party by a religious entity to limit employment or give an employment preference to members of the same religion.

Mr. Bernard explained that no city employee or applicant for employment with the city will be denied employment or promotion because of Race, Color, Religion, Disability, Sex, Sexual Orientation, Gender Identity, Veteran Status, Age or National Origin. He added that businesses may not deny advantages, facilities or services based on protected categories in places of Public Accommodation. He noted that exempt entities include a private club operating a hotel, motel, restaurant, or theater if facilities or services are restricted to its membership. He indicated that non-profit social, fraternal, educational, civic, political or religious organizations were also exempt. He stated that non-discrimination clauses in housing provisions are modeled after US and Texas Fair Housing Acts. He noted that the city prohibits what both the Federal and State Governments prohibits and adds Sexual Orientation, Gender Identity, and Veteran Status as protected categories. He explained that Fair Housing Regulations prohibit discrimination in the sale or rental of a home, as well as brokerage or appraisal services. He outlined exempted entities within Fair Housing noting that religious organizations may limit or give preference to members of the same religion.

Mr. Bernard reported that Non-Discrimination Provisions will apply to most City Contracts. He explained that there were exceptions such as the contracts exempted by the Small Business Economic Development Advocacy (SBEDA) Ordinance and Governmental Entities. He stated that the City

Council may not discriminate when making appointments to boards and Board Appointees may not discriminate while acting in his or her official capacity. He noted that the Title V Policy informally adopted previously for use by the city would be included for completeness. He outlined what the NDO would not do and noted that it would not attempt to legalize same sex marriage or require businesses to provide same sex benefits. He added that the Ordinance would not require business to have separate bathroom facilities or monitor use and would not regulate speech, religion, or political activity. He indicated that it would not create a new civil cause of action between parties.

Councilmember Bernal moved to adopt the proposed Non-Discrimination Ordinance. Councilmember Lopez seconded the motion.

Councilmember Lopez commended Councilmember Bernal for his leadership on the NDO and spoke of the great amount of dialogue that had occurred on both sides of the issue. He spoke of his service in the military and noted that Veterans deserved the proposed protections.

Councilmember Lopez moved to vote on the Veteran Status separately. Councilmember Bernal seconded the motion.

Councilmember Saldaña thanked everyone that participated in the NDO Process. He stated that it had been a very difficult issue to address and spoke of the misinformation and confusion that there had been. He asked if there was a change to the Restroom Policy. Mr. Bernard confirmed that there was not a change to the Restroom Policy. Councilmember Saldaña asked that a friendly amendment be accepted to remove the following language in Sec. 2-594 that reads: "Nothing herein shall be construed as directing any policy or practice regarding the use of restrooms, shower rooms, or similar facilities which have been designated for use by persons of the opposite sex," and replace it with the following language: "Nothing in Division 5 shall be construed as allowing any person to enter any sex-segregated space for any unlawful purpose." The friendly amendment was accepted by Councilmembers Bernal and Lopez.

Councilmember Medina thanked everyone that had been involved in the NDO Process and noted his support for the protection of Veteran Status. He stated that he was opposed to discrimination in any form and hoped that the city could heal and reunite in the future.

Councilmember Taylor stated that she was opposed to discrimination of all forms and believed that all human beings should be treated with respect. She noted that although she felt that no one should endure harassment for any reason; she could not support the NDO. She stated that the city should lead by example and that the Ordinance should only impact the city organization. She expressed concern regarding the impact the NDO would have on the ability of religious individuals to act in accordance with their faith. She requested that city staff work with small businesses to communicate the impact of

the NDO to their business if the Ordinance is approved. She commended Councilmember Bernal for his work on the issue.

Councilmember Chan thanked everyone who participated in the NDO Process. She noted her disappointment with various aspects of the process and expressed concern that the draft NDO was released without ample time for review. She stated that the NDO was confusing and could be interpreted in many different ways.

Councilmember Chan moved to table the Ordinance. Councilmember Soules seconded the motion.

Councilmember Gonzales thanked everyone that participated in the NDO Process. She stated that she was supportive of the NDO and asked that it be approved today so that the City Council could focus efforts on the budget.

Councilmember Viagran thanked the many individuals that participated in the NDO Process and spoke of the many hours that had been spent discussing the issue. She stated that the Ordinance did not take away any rights but protected the vulnerable individuals in the community. She expressed her support for the NDO and added that she hoped for healing and reconciliation throughout the community.

Councilmember Nirenberg stated that he was voting in favor of the NDO for San Antonio. He spoke of the great amount of discussion that had occurred on the issue and believed that this was the right thing to do. He noted that the NDO exempted religious organizations and most non-profits and that religious liberties and individual rights would be protected.

Councilmember Soules stated that his staff had contacted the Equal Employment Opportunity Commission (EEOC) and they indicated that they only investigate workplace discrimination that violates Federal Law. Mr. Bernard stated that the EEOC would investigate any violation of Title VII. Councilmember Soules expressed concern that the issue related to Restrooms was still unclear and that the issue of appointing Board and Commission Members could cause unintended consequences. He asked why the City Commission on Veteran's Affairs was not involved in the process since Veteran Status was being included in the NDO. He stated that he could not support the NDO which was poorly written and lacks due process.

Councilmember Bernal stated that a draft of the NDO had been public for many months and spoke of the great amount of time that he spent working on same. He noted that he had begun working on the NDO to represent the community and especially those most vulnerable. He spoke of his experiences in high school and college with LGBT Individuals. He stated that he had discussed the issue with religious leaders throughout the city and had included many of their recommendations.

Mayor Castro thanked Councilmember Bernal, City Councilmembers, and the citizens for their comments on the NDO. He stated that the Ordinance took into account the views of different people and had significant support from all sectors of the community. He noted that the Ordinance would not infringe on anyone's religious beliefs and that he would like for everyone to be treated equally.

The motion by Councilmember Chan to Table the proposed Non-Discrimination Ordinance was voted on first.

Henry Flores representing the proposed development spoke in support of the zoning request. He stated that they had received a recommendation for approval from city staff and the Zoning Commission. He outlined the amenities that would be offered at the apartment complex including a pool and business center. He mentioned that they had received Federal Tax Credits for the project which would result in lower operating costs and rent.

Lydia Garcia stated that she had lived in the area for 18 years and was opposed to the zoning request. She expressed concern with safety and traffic in the area.

Walter Martinez spoke in support of the zoning request. He stated that there was a great need throughout the city for quality, affordable housing. He noted that traffic concerns should not deter growth and development.

Zulema Codello addressed the City Council in support of the zoning request noting that she had taught in the District and Area for 42 Years. She stated that the developer was addressing traffic concerns and that the development would be an asset to the community.

Henry Rodriguez read a letter of support for the zoning request from the American GI Forum Veterans Outreach Program. He stated that the project would help working people and felt it would benefit the community.

Rebecca Olague stated that she lived within 200 feet of the requested zoning change and was in opposition. She expressed concerns with traffic and noted that the development was not in the best interest of the neighborhood.

Jerry Arredondo addressed the City Council in support of the zoning request. He stated that they would be down zoning the property and had met with city staff regarding alleviating traffic concerns. He noted that the development would provide affordable housing in the area and was a Tax Credit Development.

Councilmember Lopez stated that the development was proposed at the corner of Potranco and Richland Hills which was a high-traffic area. He noted that it was in an area experiencing a high amount of growth and asked of the traffic circulation pattern. Christina De La Cruz of Public Works stated that they were working with a consultant to perform a Comprehensive Traffic Study of the cumulative development occurring in the area. She indicated that currently, Richland Hills was being used as a connector during peak times. Councilmember Lopez spoke of the importance of a Data Driven Study to manage growth throughout the city.

Mayor Castro called upon the individual registered to speak.

Winnifred Murnin stated that she was the only homeowner adjacent to the property under consideration that would be negatively affected. She expressed concern with landscaping and parking but stated that she would not be in opposition if the issues could be positively addressed.

Frank Korte stated that they have worked with the neighborhood association on various issues and that all of the conditions were acceptable.

Councilmember Nirenberg stated that he was pleased that the community members and applicant had worked together on the request. He asked of the landscape buffer and the reduction of parking spaces. Mr. Jacks replied that the landscape buffer requirement could be addressed today. However; the reduction in the number of parking spaces would be considered a variance and could only be approved by the Zoning Board of Adjustment. He noted that one space could be reduced administratively.

Councilmember Nirenberg moved to adopt the proposed Ordinance with city staff recommendation with a revised site plan and the following condition: A Type A Landscape Buffer shall be required along Rustic Lane and Honeycomb Drive except any portion that would violate clear vision standards. Councilmember Saldaña seconded the motion.
