Dear City Council Members,

I am writing to inform the members of the City Council of San Antonio of my intent to file an appeal for the denial of application for a Residential Building Contractors Registration.

I was denied under the following provisions outlined in Section 10-116(B) of the City's code, specifically Sections 10-116(b)(3) and 116(b)(5)c.

- 10-116(b)(3): A failure to disclose under subsections (b) shall be sufficient grounds to deny the application.
- 10-116(b)(5): A person may not be issued a certificate of registration unless the person:

c. The Building Official is satisfied with the person's honesty, integrity, and trustworthiness based on information supplied and discovered in connection with the application.

On the application which I have enclosed it asked if I have ever been charged or convicted of crimes of moral turpitude. In which I check no to all. Although I have been convicted of a felony in 1999, it was not a crime of moral turpitude. Also enclosed, I have a list of crimes of moral turpitude in the State Of Texas. I have also included my college transcripts, and proof of my in-active real estate license of which I hold in the State of Texas. The Texas Real Estate Commission Also does a background check for crimes of moral turpitude.

Enclosed is a proposal/contract for Perez Home Improvements in which you will notice at mid page in parenthesis that total is "due upon completion", meaning no money down until the job is completely finished. I have also included copies of the least three(3) jobs I have done with permission from the satisfied customer as references.

Perez Home Improvements is a company that was started by my late father in 1995. We have been proud members of the Better Business Bureau with no complaints against us.

On July 18, 2013 my father passed away while under the care of the Veterans Administration Hospital. Prior to being hospitalized, in May he lost all mobility due to spinal stenosis. Being that he had become an invalid, I have been running the company for the last two(2) years. Since his license

has expired I am attempting to obtain a registration of my own. I've worked with my father since 1991, mostly roofing and small additions to homes.

I assure this council that I am honest, trustworthy, and take pride in my work. I would also be more than willing to provide more references from customers that I have done work for. I've also included my criminal record to verify to this council that I have never committed theft in my life nor do I intend to. I mention this because it seems to have been an argument brought against me at my hearing in front of the Planning and Development board. This is also the reason for the copy of the contract stating that we ask for no money down.

I pray that you the members of the City Council of San Antonio take into consideration the dates of my criminal offenses, the majority being prior to 1999. I have made mistakes in the past and in my younger years, but am now a 39 year old man who is just looking to make an honest living doing what I know best and continue the legacy and reputation that we have built over the last 18 years here at Perez Home Improvements. I thank you for your time, consideration and patience.
