The City Council convened in a Regular Meeting. The City Clerk took the Roll Call as follows:

Present: 11 - Mayor Castro, Bernal, Taylor, Viagran, Saldaña, Gonzales, Lopez, Medina, Nirenberg, Krier and Gallagher

1. Mayor Castro led the Pledge of Allegiance to the Flag of the United States of America.
2. The Invocation was delivered by Reverend David Brockhouse, Mt. Olive Lutheran Church, guest of Councilmember Rey Saldaña, District 4.
3. Approval of Minutes for the December 4 - 5, 2013 City Council Meetings

Councilmember Nirenberg moved to approve the Minutes for the December 4-5, 2013 City Council Meetings. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

POINT OF PERSONAL PRIVILEGE

Councilmember Medina recognized Mr. Randy Murdock, District 7 Leader that served on the Animal Care Services Board and the Watershed Improvement Advisory Committee. Councilmember Medina stated that Mr. Murdock passed away unexpectedly but wanted to recognize him for his great service and leadership. He asked for a moment of silence in honor of Mr. Murdock. Mayor Castro stated that he had the opportunity to meet Mr. Murdock a few years ago and spoke of his passion for the community.

CONSENT AGENDA ITEMS

Item 4 was pulled for Individual Consideration. Councilmember Bernal moved to approve the remaining Consent Agenda Items. Councilmember Lopez seconded the motion.

Councilmember Lopez highlighted the Wolff Stadium Repairs Project (Item 6) and stated that it was the boundary between Edgewood and Northside. He spoke of the great amount of revitalization occurring in District 6 and noted that Wolff Stadium had been a catalyst for the activity in the area.

Mayor Castro noted that there were no individuals registered to speak.

Faris Hodge, Jr. submitted written testimony in favor of Items 4-6, and 8-10. He wrote that Board Members should be interviewed on television (Item 11).

The City Clerk read the caption for Item 4:

- 4.** An Ordinance accepting the bid from Maldonado Nursery & Landscape, Inc. for mowing of Right of Ways, Medians & Buyout Properties for an estimated annual cost of \$600,000.00. [Ben Gorzell, Chief Financial Officer; Troy Elliott, Director, Finance]

Councilmember Medina highlighted the fact that Maldonado Nursery & Landscape had started out as a Small Business and had grown into a prosperous and successful business. He asked of the three companies that bid on the project but did not qualify. Troy Elliott replied that they had utilized a Small Business Tool for this contract at the Subcontracting Level to include a 12% Minority and Women Business Enterprise (MWBE) Participation.

He noted that the other companies that bid did not meet the 12% Subcontracting Goal. Councilmember Medina asked what staff was doing to help Small Businesses reach their goals in the future. Mr. Elliott responded that the Economic Development Department (EDD) and Purchasing Division reaches out to Small Businesses and holds Pre-Submittal Conferences to walk them through the bid requirements. He added that EDD provided a great amount of outreach to Small Businesses.

Mayor Castro asked of the Right-of-Way Mowing Cycles. Arthur Reinhardt replied that through this new contract, they would increase mowing from nine cycles per year to 24 cycles per year. Mayor Castro spoke of the importance of ensuring a sufficient number of cycles and keeping the city looking good.

Councilmember Viagran asked of the calls to 3-1-1 for mowing and their impact to the schedule. Mr. Reinhardt replied that the mowing was divided into quadrants and zones and that there was capacity to address issues with In-House Crews if necessary.

Councilmember Medina moved to adopt the proposed ordinance. Councilmember Bernal seconded the motion. The motion prevailed by the following vote:
