

**AN ORDINANCE      2014 - 04 - 03 - 0205**

**AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION  
AND ACCEPTANCE OF FUNDS PROVIDED THROUGH THE  
TEXAS COMMISSION ON THE ARTS FOR PROGRAMMING  
FOR THE SAN ANTONIO PUBLIC LIBRARY'S SUMMER  
READING CLUB IN AN AMOUNT NOT TO EXCEED \$1,925.00  
FOR THE PERIOD JUNE 1, 2014 TO AUGUST 30, 2014.**

**WHEREAS**, the 2014 Mayor's Summer Reading Club centers on science using the theme "Fizz, Boom, Read!"; and

**WHEREAS**, in conjunction with the Reading Club, the San Antonio Public Library will hire program presenters who will engage children's interest, promote science topics and encourage summer reading; and

**WHEREAS**, J. Lucas Miller, the Singing Biologist, is one such presenter who will be funded through this grant; and

**WHEREAS**, Mr. Miller is on the Texas Commission on the Arts performance roster; and

**WHEREAS**, as such, the Commission can provide 30 to 50% of the funding necessary to bring Mr. Lucas to San Antonio Public Library locations; and

**WHEREAS**, Mr. Miller has agreed to present 15 programs at a cost of \$255.00 per show for a total of \$3,825.00; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee or the Director of the San Antonio Public Library or his designee is authorized to submit a grant application and accept funds provided through the Texas Commission on the Arts for programming for the San Antonio Public Library's Summer Reading Club in an amount not to exceed \$1,925.00 for the period June 1, 2014 to August 30, 2014. A copy of said application which is incorporated herein for all purposes is on file with the San Antonio Public Library.

**SECTION 2.** The City Manager or her designee, or the Director of the San Antonio Public Library or his designee is further authorized to execute any and all necessary documents to effectuate said application and acceptance.

**SECTION 3.** Upon approval of this ordinance, a new fund and internal order number will be created, upon which the sum of \$1,925.00 will be appropriated from the Texas Commission on the Arts. The proposed budget, which is attached hereto and incorporated herein for all purposes as **Attachment I**, is approved and adopted for entry in the City books. A formal final budget which will include Internal Order numbers and General Ledger numbers will be submitted by the department upon award.

**SECTION 4.** Payment is authorized to J. Lucas Miller in the amount of \$1,925.00 upon issuance of a Purchase Order.


**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


