

AN ORDINANCE 2014 - 04 - 10 - 0220

**APPOINTING TWO FULL-TIME MUNICIPAL COURT JUDGES,
APPOINTING ONE PART-TIME MUNICIPAL COURT JUDGE, AND
RE-APPOINTING SEVEN FULL-TIME MUNICIPAL COURT
JUDGES FOR A TERM EFFECTIVE MAY 1, 2014 TO APRIL 30,
2016; AND ESTABLISHING JUDICIAL SALARIES AND BENEFITS.**

WHEREAS, there are currently nine full-time Municipal Court Judges who were previously appointed by City Council with terms due to expire on April 30, 2014; and

WHEREAS, two of the Judges are not seeking reappointment, thereby creating two vacancies; and

WHEREAS, on March 31, 2013, the Governance Committee interviewed six candidates and based on their qualifications and the interviews, the Committee has recommended the appointments of Lisa M. Gonzales and Margarita S. Pol to fill the vacancies; and

WHEREAS, based on the recommendation of Presiding Municipal Court Judge John Bull and the confirmation that each continues to meet the qualifications to serve, the Governance Committee also recommended the re-appointment of the remaining seven incumbent, full-time Municipal Court Judges and the appointment of a part-time Municipal Court Judge; and

WHEREAS, after review and consideration of the qualifications and performance of each of the candidates, the City Council finds that is in the best interest of the City to make the following appointments; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following persons are appointed to serve as full-time Judges for the City of San Antonio Municipal Court effective May 1, 2014 to April 30, 2016:

SECTION 2. The following person is appointed to serve as a part-time Judge for the City of San Antonio Municipal Court effective May 1, 2014 to April 30, 2016:

SECTION 3. Annual salaries for the full-time Judges are established at \$101,290.00. Part-time Judges are paid an hourly rate of \$43.71. Life insurance, health and retirement benefits currently extended to City employees are extended to the full-time Municipal Court Judges.

SECTION 4. Judicial salaries are part of the Court's FY 2013-2014 budget.


SECTION 5. This Ordinance shall be effective on April 30, 2014.


