## AN ORDINANCE 2014 - 05 - 01 - 0279

AUTHORIZING THE SUBMISSION OF A \$12,000.00 GRANT APPLICATION TO THE TEXAS A&M FOREST SERVICE FOR A TEXAS INTRASTATE FIRE MUTUAL AID SYSTEM GRANT PROGRAM GRANT TO FUND SAN ANTONIO FIRE DEPARTMENT TRAINING; AND AUTHORIZING THE ACCEPTANCE OF FUNDS, UPON AWARD.

WHEREAS, the Texas Intrastate Fire Mutual Aid System (TIFMAS) Grant Program, which is administered by the Texas A&M Forest Service, has grant funds of as much as \$12,000.00 available for training tuition for the San Antonio Fire Department (SAFD); and

WHEREAS, no matching contribution is required; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager and her designee are hereby authorized to submit a grant application in an amount not to exceed \$12,000.00 to the TIFMAS Grant Program for training tuition for the SAFD. The City Manager and her designee are hereby authorized to accept said grant, if awarded under the same terms and conditions as applied for. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said application and acceptance.

**SECTION 2.** Upon acceptance of this award, a new fund and internal order number will be created, upon which the sum of \$12,000.00 will be appropriated from TIFMAS.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
