AN ORDINANCE 2014 - 05 - 29 - 0 374

AUTHORIZING THE SUBMISSION OF GRANT APPLICATIONS TO THE ALAMO AREA COUNCIL OF GOVERNMENTS FOR THE SENIOR NUTRITION AND TRANSPORTATION PROGRAMS, IN AMOUNTS UP TO \$1,400,000.00 AND \$300,000.00, RESPECTIVELY, FOR THE PROVISION OF SENIOR SERVICES FOR FY 2015 THROUGH FY 2016.

WHEREAS, the City of San Antonio Department of Human Services provides congregate meals and transportation services to seniors age 60 and over living in San Antonio and Bexar County; and

WHEREAS, these programs are funded with general funds and federal grants, awarded since 1973, by the Texas Department of Aging and Disability Services through the Alamo Area Council of Governments; and

WHEREAS, the City's Senior Nutrition Program serves approximately 2,800 meals daily, Monday through Friday, at the City's Senior Center sites located throughout the community; and

WHEREAS, the City's Senior Transportation Program provides essential door-to-door services to and from the City's Senior Centers and provides approximately 72,000 one-way trips annually; and

WHEREAS, a ten percent cash match is required for each grant award, and since at least 1983, the City has overmatched grant funds in order to ensure community access to nutrition services; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the Department of Human Services (DHS) or her designee, is authorized to submit grant applications to the Alamo Area Council of Governments (AACOG) and to accept funds upon award in an amount up to \$1,400,000.00 for the Senior Nutrition Program and up to \$300,000.00 for the Transportation Program for the period FY 2015 through FY 2016. Copies of the applications are on file with DHS. The City Manager or her designee, or the Director of DHS or her designee, is further authorized to execute any and all necessary documents to effectuate said applications.

SECTION 2. Should funding be awarded, DHS will go back to City Council to accept the award amounts and authorize the cash match amount and any budgets and personnel complement associated with the acceptance of funds.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
