**Convention & Visitors Commission**

The Economic and Community Development City Council Committee will review and recommend an applicant for one available slot on the Convention and Visitors Commission (CVC). The San Antonio Hotel and Lodging Association (SAHLA) has nominated Mr. Paul Tang, General Manager for the Grand Hyatt Hotel, to replace Mr. Jim Quinn, as one of their six representatives on the CVC.

**BACKGROUND INFORMATION:**

**Airport Advisory Commission**

The Airport Advisory Commission (AAC) is comprised of 19 members appointed by City Council at-large for staggered two-year terms. The Economic and Community Development Council Committee reviewed and recommended 10 applicants for appointment on April 1, 2014 leaving one Community Representative Slot open.

**Convention and Visitors Commission**

The Convention and Visitors Commission is comprised of 25 members appointed by the City Council for two-year terms. Board Member Jim Quinn has relocated. Said replacement is to be recommended by the SAHLA. The SAHLA has recommended Paul Tang as his replacement.

**ISSUE:**

Board appointments require full City Council approval.

**FISCAL IMPACT:**

There is no fiscal impact.

**RECOMMENDATION:**

The Office of the City Clerk recommends approval of the Council Committee's decision and that recommendations for one member to the Airport Advisory Commission and one member to the Convention and Visitors Commission be submitted to the full City Council Meeting on June 19, 2014.
