WHEREAS, the City released a Request for Competitive Sealed Proposals to provide the City with transportation for senior citizens to and from non-emergency medical and hospital appointments; and

SECTION 1. The proposal submitted by Greater San Antonio Transportation Company d/b/a Yellow Cab to provide the City with transportation for senior citizens to and from non-emergency medical and hospital appointments is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. SECTION 2. Funds have been appropriated in the below designated funds and internal orders. Payment is authorized to Greater San Antonio Transportation Company d/b/a Yellow Cab upon issuance of a Purchase Order.
