## **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Section 17.F. of the FY2014 Budget Ordinance, Ordinance No. 2013-09-12-0627, is hereby amended to reads as follows:

**SECTION 2.** Funding for this Ordinance will be funded through SAPD's Fiscal Year 2014 General Fund Budget.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** Except as amended by prior ordinances, and as amended by the foregoing provisions of this Ordinance, the FY 2014 Budget and the FY 2014 Budget Ordinance shall remain unchanged and in full force and effect.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
