SETTING THE FOLLOWING DATES, TIMES, AND LOCATIONS FOR THE FIRST AND SECOND PUBLIC HEARINGS ON THE PROPOSED BUDGET FOR FY 2014-2015: WEDNESDAY, AUGUST 20, 2014, 6:00 P.M., AND WEDNESDAY, SEPTEMBER 10, 2014, 6:00 P.M., IN THE CITY COUNCIL CHAMBER, 114 W. COMMERCE ST.; AND SETTING THE FOLLOWING DATES, TIMES AND LOCATIONS FOR THE FIRST AND SECOND PUBLIC HEARINGS ON THE PROPOSED TAX RATE FOR THE TAX YEAR BEGINNING JANUARY 1, 2014 AND ENDING DECEMBER 31, 2014: WEDNESDAY, AUGUST 20, 2014, 6:00 P.M., AND WEDNESDAY, SEPTEMBER 10, 2014, 6:00 P.M., IN THE CITY COUNCIL CHAMBER, 114 W. COMMERCE ST..

WHEREAS, a public hearing on the proposed annual budget of the City of San Antonio is required by Section 102.006 of the Texas Local Government Code and Section 82 of the City Charter; and

WHEREAS, two public hearings on the proposed annual tax rate of the City of San Antonio are required by Chapter 26 of the Texas Property Tax Code if it exceeds the lower of the rollback rate or the effective rate; and

WHEREAS, the proposed Tax Year 2014 total tax rate of 56.569 cents per \$100.00 of taxable valuation does exceed the Tax Year 2014 effective tax rate of 54.175 cents per \$100.00 of taxable valuation, thus requiring the two public hearings described above; and

WHEREAS, the City Council now wishes to officially set the dates, times, and locations for all four of these public hearings and provide for public notice; NOW, THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Two (2) public hearings on the Fiscal Year 2014-2015 proposed budget are hereby scheduled, for Wednesday, August 20, 2014, from 6:00 p.m. until completion, and for Wednesday, September 10, 2014, from 6:00 p.m. until completion, with both hearings to be held in the City Council Chamber, 114 W. Commerce St.

SECTION 2. Because the proposed tax rate for the Tax Year beginning January 1, 2014 and ending December 31, 2014 heretofore set by the City Council by an Ordinance approved and adopted on the same date as this Ordinance exceeds the lower of the rollback rate or the effective rate, two public hearings on the proposed tax rate are required by Chapter 26 of the Texas Property Tax Code. The first public hearing on the proposed tax rate is hereby scheduled for Wednesday, August 20, 2014 from 6:00 p.m. until completion, in the City Council Chamber, 114 W. Commerce St. The second public hearing on the proposed tax rate is hereby scheduled for Wednesday, September 10, 2014, from 6:00 p.m. until completion, in the City Council Chamber, 114 W. Commerce St.

SECTION 3. City staff is hereby directed to publish, post and broadcast notice of each of these public hearings as required by applicable laws, including, but not limited to, the City Charter, Chapter 102 of the Local Government Code, as amended (budget), and Chapter 26 of the Texas Property Tax Code and Chapter 140 of the Local Government Code (tax rate).

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
