# AN ORDINANCE 2014 - 08 - 07 - 0522

AUTHORIZING AN AMENDMENT TO THE PET REGISTRATION SERVICES CONTRACT WITH PETDATA, INC., TO EXTEND THE TERM OF THE CONTRACT FOR ONE YEAR, FUNDED BY LICENSE FEES COLLECTED BY THE CITY.

WHEREAS, the City of San Antonio and PetData, Inc. entered into an agreement for animal licensing services, under which the parties set forth their agreement regarding PetData, Inc.'s role in the management of the City's pet licensing program; and

WHEREAS, the agreement was for a term beginning August 1, 2011 and ending July 31, 2012, and provided for up to two successive one year renewal periods, both of which have been exercised; and

WHEREAS, the City wishes to amend the agreement to provide for one additional renewal period; NOW THEREFORE:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager, the Director of Animal Care Services, the Director of Finance, and their designees, are hereby authorized to execute an amendment to the agreement with PetData, Inc. to provide for one additional one year extension. A copy of the amendment is attached hereto and incorporated herein for all purposes as **Exhibit I**.

**SECTION 2.** The amounts will be encumbered upon issuance of a purchase order, and payment is authorized to PetData, Inc. All expenditures will be in accordance with the Fiscal Year 2014 and subsequent budgets that fall within the term period of this contract approved by City Council.

**SECTION 3.** This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.

# SECOND AMENDMENT TO AGREEMENT FOR ANIMAL LICENSING SERVICES

This second amendment to the agreement for animal licensing services is entered into by and between the City of San Antonio ("City") and PetData, Inc. ("PetData"), referred to collectively herein as the "Parties".

WHEREAS, City and PetData entered into an agreement entitled "Agreement for Animal Licensing Services" ("Original Agreement"), under which the Parties set forth their agreement regarding PetData's role in the management of City's pet licensing program; and

WHEREAS, the Original Agreement was for a term beginning August 1, 2011 and ending July 31, 2012, and provided for up to two successive one year renewal periods, both of which have been exercised; and

WHEREAS, City wishes to amend the Original Agreement to provide for additional renewal periods;

NOW, IN ACCORDANCE THEREWITH, the Parties agree as follows:

#### I. AMENDMENTS

- A. Section 2.2 of the Original Agreement is hereby revised to read as follows:
- 2.2 This Agreement may be renewed by City for three successive one year periods on the same terms and conditions. Renewals shall be in writing and signed by Director without further action by the San Antonio City Council. If all renewals are exercised, this agreement shall expire on July 31, 2015.

### II. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the Original Agreement not specifically mentioned herein and revised by this document, or previously amended, are hereby retained in their entirety, unchanged, and shall remain in full force in effect for the duration of said Original Agreement.

## III. ENTIRE AGREEMENT

This agreement, as amended, embodies the complete agreement of the parties hereto with regard

to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.
