AN ORDINANCE

AUTHORIZING AN INTERAGENCY PARTICIPATION AGREEMENT WITH CPS ENERGY TO TRANSFER OWNERSHIP OF ELECTRIC VEHICLE CHARGING STATIONS, USED BY THE CENTER CITY DEVELOPMENT AND OPERATIONS DEPARTMENT AND THE LIBRARY DEPARTMENT, IN SUPPORT OF CPS ENERGY'S EXISTING NETWORK OF ELECTRIC CHARGING STATIONS

WHEREAS, President Obama signed the American Recovery and Reinvestment Act of 2009 (ARRA) into law on February 17, 2009, which provides a total of \$787 billion in spending and tax cuts, to preserve and create jobs, and make investments in infrastructure, energy and science, unemployment assistance, and State and local stabilization; and

WHEREAS, the Office of Sustainability secured \$12.8 million in U.S. Department of Energy (DOE) Energy Efficiency and Conservation Block Grants (EECBG) funding to support, manage and implement the reduction of fossil fuel emissions and improve energy efficiency in the building, transportation and other appropriate sectors; and

WHEREAS, to encourage the use of electric-powered vehicles by citizens to increase energy savings while also improving air and water quality, reducing greenhouse gas emissions, and reducing reliance on imported fossil fuels, grant funds totaling \$9,371.58 were used to purchase and install six EV Charge America electric vehicle charging stations located in COSA parking facilities, as authorized by City Council under Ordinance 2009-12-10-1037; and

WHEREAS, CPS Energy operates over 135 ChargePoint electric vehicle charging stations at numerous locations throughout their service area; the coordination of the City and CPS Energy initiatives will increase efficiency and result in enhanced utilization of resources; the City will transfer ownership of the six EV charging stations to CPS Energy and CPS Energy will expedite replacement of the six stations with ChargePoint stations; and

WHEREAS, the six replaced stations will continue to be public-charging stations for citizens to charge their vehicles without a fee and the City will continue to fund the cost of electricity to operate the electric vehicle charging stations for approximately \$50.00 per month in electric utility usage; and

WHEREAS, this Ordinance authorizes an Interagency Participation Agreement with CPS Energy to transfer ownership of six electric vehicle charging stations, used by the Center City Development and Operations Department and the Library Department, in support of CPS Energy's existing network of electric charging stations; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, or the Director, Office of Sustainability (OS), or his designee, is hereby authorized to negotiate and execute an Interagency Participation Agreement with CPS Energy to transfer ownership of six electric vehicle charging stations, used by the Center City Development and Operations Department and the Library Department, in support of CPS Energy's existing network of electric charging stations. A copy of the Agreement, in substantially final form, is attached and incorporated herein for all purposes as **Attachment I**. The execution authority granted by this Ordinance expires 60 days after the effective date.

SECTION 2. The disposition of property must be coordinated through the City's Finance Department to assure the removal of these assets out of the City's financial records and to record the proper accounting transactions.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.
