ASSIGNMENT OF LEASE AGREEMENT (WITH LANDLORD'S CONSENT)

WHEREAS, the City of San Antonio, a Texas Municipal Corporation, acting by and through its City Manager pursuant to Ordinance No. 90983 passed and approved by the City Council on December 9, 1999, as LANDLORD ("CITY"), entered into that certain Lease Agreement ("LEASE") with AZTEC ON THE RIVER, LTD., a Texas Limited Partnership, whose general partner is EURO-ALAMO MANAGEMENT, INC., a Texas corporation, ("ASSIGNOR"), for the lease of approximately 1,409 square feet within NCB 116:

WHEREAS, AZTEC ON THE RIVER, LTD. desires, as ASSIGNOR, to convey and assign TENANT'S leasehold interest under the LEASE to AZTEC FAMILY GROUP, LLC as ASSIGNEE; and

WHEREAS, said assignment requires the prior approval of CITY; and

WHEREAS, ASSIGNEE desires to assume from ASSIGNOR all of ASSIGNOR'S rights, title, and interest as TENANT in and to the LEASE, and all of ASSIGNOR'S benefits and obligations there under; and

WHEREAS, CITY desires to give its consent to ASSIGNOR'S assignment of ASSIGNOR'S interest in the LEASE to ASSIGNEE and to ASSIGNEE'S assumption of TENANT'S obligations there under; and

WHEREAS, amending the LEASE is in CITY and TENANT'S best interest; NOW THEREFORE,

In consideration of the mutual covenants and agreements set forth below the parties agree as follows:

- CONVEYANCE AND ASSIGNMENT: ASSIGNOR does hereby grant, bargain, sell, convey, assign, transfer, set over, and deliver to ASSIGNEE, all of ASSIGNOR'S rights, title, and interest in and to the LEASE, including and also without limitation, all of the rights, duties, obligations, and liabilities of ASSIGNOR in, to, and under the LEASE to pay rent and to observe and perform all other covenants and duties of TENANT there under.
- ASSUMPTION: By its execution hereof, ASSIGNEE hereby assumes and agrees to perform all of the terms, covenants, and conditions of the LEASE on the part of the TENANT therein required to be performed arising from and after the date hereof, and ASSIGNEE releases ASSIGNOR from all liability for such obligations.
 - ASSIGNEE hereby accepts the assignment of said ASSIGNOR'S rights, title and interest in and to the LEASE and; ASSIGNEE recognizes the superior fee title in and to the land and premises held by the CITY, as Landlord, and CITY'S right of reversion at the end of the LEASE term, whether occasioned by default or passage of time, as well as, the rights and benefits of every description whatsoever belonging to or accruing to the benefits of the CITY under the LEASE.
- CONSENT: CITY hereby consents to the assignment by AZTEC ON THE RIVER, LTD., as ASSIGNOR, and the assumption by AZTEC FAMILY GROUP, LLC, as ASSIGNEE of said LEASE, originally approved by City Council pursuant to Ordinance number 90983 passed and approved on December 9, 1999.

4. <u>ACKNOWLEDGEMENT OF READING</u>: The parties hereto acknowledge that they have thoroughly read this Assignment of Lease Agreement, including any exhibits or attachments hereto, and have sought and received whatsoever competent advice and counsel which was necessary for them to form a full and complete understanding of their rights and obligations herein, and having done so, do hereby execute this document.
