AUTHORIZING AN AMENDMENT TO THE EXISTING CONTRACT WITH BUCK CONSULTANTS, LLC, TO EXTEND THE TERM OF THE CONTRACT FOR AN AMOUNT UP TO \$275,000.00 BEGINNING JUNE 19, 2015 THROUGH DECEMBER 31, 2015; AND AMENDING THE CONTRACT TO ALLOW FOR CONTINUED SERVICES TO INCLUDE ACTUARIAL ANALYSIS, COST ANALYSIS, AND REVIEW OF ALL MEDICAL PLAN DESIGNS.

WHEREAS, the City of San Antonio issued a Request of Proposals for professional consulting services; and

WHEREAS, after conducting an evaluation process, City Staff recommends Buck Consultants, LLC be selected to perform the employee benefit consulting services under the contract; and

WHEREAS, said Contract provided for a one year term, expiring on June 19, 2015; and

WHEREAS, the parties wish to amend the terms of the contract to extend the contract term beginning June 19, 2015 through December 31, 2015; and

WHEREAS, the parties additionally wish to amend the term to allow for month-to-month extensions to begin January 1, 2016 at City's option, on an as-needed basis, contingent on availability of funds; and

WHEREAS, the parties also wish to amend the contract to provide continued consulting services to include actuarial analysis, cost analysis, Third Party Administrator Request for Proposal assistance; stop loss; and review of all medical plan designs; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City's contract with Buck Consultants, LLC is hereby amended to extend the contract for a period from June 19, 2015 through December 31, 2015, and allowing for month-to-month extensions beginning January 1, 2016 based on availability of funding. The contract is also amended to provide continued consulting services, to include actuarial analysis; cost analysis; Third Party Administrator Request for Proposal assistance; stop loss; and review of all medical plan designs, as set forth in Attachment 1. The City Manager, or her designee, is authorized to execute the Amendment and Extension, attached hereto and incorporated herein as Attachment 1.

SECTION 2. Funds are budgeted for this contract in fund 75002000, Cost Center 1002010004, and General Ledger 5201040, as part of the Fiscal Year 2015 Budget.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon passage of eight affirmative votes; otherwise, it is effective ten days after passage.

AMENDMENT AND EXTENSION OF PROFESSIONAL SERVICES CONTRACT

This Amendment and Extension of the Professional Services Contract with Buck Consultant's, LLC, (hereinafter referred to as "CONSULTANT") to provide comprehensive benefits consulting services to the City of San Antonio (hereinafter referred to as "CITY"), is as follows:

WHEREAS, through Ordinance No. 2014-06-19-0463, passed and approved June 19, 2014, City Council authorized the execution of the consulting contract (hereinafter the "Contract"), with CONSULTANT; and

WHEREAS, said Contract provides that CONSULTANT shall provide comprehensive benefits consulting services; and

WHEREAS, CITY and CONSULTANT want to amend the contract term and allow for an extension to begin June 19, 2015 and end December 31, 2015 with the option to renew at City's option on a month-to-month basis provided funds are available; and

WHEREAS, the Parties wish to amend the Contract as set forth in the attached agreement; NOW THEREFORE:

I. Renewal

Pursuant to the provisions of Section VIII of the Contract, CITY and CONSULTANT mutually agree to extend the term of said Contract commencing on June 19, 2015 and terminating December 31, 2015 as outlined in Exhibit A, unless CITY exercises option to renew on a month-to-month basis provided funds are available and have not exceeded \$275,000.00, under the same terms and conditions as stated in said Contract.

II. Amendment

Section II, Scope, is amended as follows:

- 2.4 CONSULTANT shall provide the following benefit consulting services:
 - 2.4.1 Stop Loss (for the entire Plan)
 - 2.4.2 Request For Proposal assistance as outlined in Exhibit B and up to \$30,000.00 in additional services as agreed to in advance by both Parties.

Note: Some of Buck Consultants' work includes providing consulting compliance services to the City of San Antonio. Buck Consultants is not a law firm and does not practice law nor is Buck or any associated entity engaged to do so. All such compliance services are for the City's review and further consideration.

Section V. Consideration and Billing, is amended as follows:

5.1 In consideration of CONSULTANT'S performance hereunder, CITY shall pay to CONSULTANT an amount not to exceed \$275,000.

III.

All other terms, conditions, covenants and provisions of the Contract approved through Ordinance No. 2014-06-19-0463 and not specifically provided for herein shall remain in full force and effect for the term.
