AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE TEXAS DEPARTMENT OF TRANSPORTATION FOR FUNDING CONSIDERATION UNDER THE TRAFFIC SAFETY GRANT PROGRAM AND AUTHORIZING THE ACCEPTANCE UP TO \$35,992.96 IN FEDERAL FUNDS IF AWARDED.

WHEREAS, the City of San Antonio is developing a Strategic Multi-Modal Transportation Plan (SMMTP) to begin planning for the major population growth expected by the year 2040 and an effort to emphasize multi-modal transportation, walking and biking safety, especially around schools, has become a national focus due to the increased number of pedestrian and bicycle accidents each year, it is imperative that our community find a way to minimize pedestrian and bicycle fatalities; and

WHEREAS, the first portion of this grant is to prepare a school safety kit for local schools to educate their students walking and biking safety by providing a variety of items such as educational curriculum, informational handouts, web resources, safety facts, giveaway items and surveys; and

WHEREAS, this approach is intended to target education in a local neighborhood, in order to reach the students where they live and travel; and

WHEREAS, the second approach to promoting walking and biking safety is to address safety in adult populations through distribution of materials in the community which will be used to educate citizens on the importance of using designated crosswalks as well as to motorists to drive attentively; and

WHEREAS, to assist the City through this educational outreach, the City has applied for a grant from the Texas Department of Transportation to provide printed materials and giveaways to include in safety tool kits; and

WHEREAS, staff was asked to quantify the amount of funding that would be needed to assemble these tool kits and it is estimated that this will cost \$44,991.20 to focus on the walking and bike safety with the goal of the grant to educate as many students as possible with tool kits, as well as, promote safety throughout San Antonio for all-ages; and

WHEREAS, this Ordinance authorizes the City Manager or her designee, to submit an application to the Texas Department of Transportation for funding consideration under the Traffic Safety Grant Program and authorizes the acceptance of \$35,992.96 in federal funds if awarded; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

- **SECTION 1.** The City Manager or her designee, or the Director of the Transportation and Capital Improvements Department or his designee is hereby authorized to apply for and accept grant funds in the amount up to \$35,992.96 from the Texas Department of Transportation (TxDOT).
- **SECTION 2.** Fund 2605940001 entitled "TXDOT STRATEGIC MULTI-MODAL" and internal order 140000000186 are hereby designated for use in the accounting for the fiscal transaction in the ratification of this grant.
- **SECTION 3.** Funds are authorized to be received from TXDOT to SAP Fund 46099000, Grants Other Projects, SAP Project Definition 40-00459, Strategic Transportation Multi-Modal Plan, and the budget shall be revised by increasing WBS element 40-00459-90-14-01 entitled Transfer from I/O# 14000000186 TXDot Grant (TXDot), SAP GL Account 6101100 Interfund Transfer In, by the amount \$35,992.96.
- **SECTION 4.** The amount of \$8,998.24 is authorized to be transferred from SAP Fund 11001000, General Fund, SAP Internal Order # 39000000499, SAP GL account 6102100 Interfund Transfer out entitled From 11001000 to I/O# 140000000186, to SAP Fund 2605940001.
- **SECTION 5.** The budget in SAP Fund 2605940001, TXDot Contributions, shall be revised by increasing SAP Internal Order # 140000000186 entitled TXDOT- Strategic Transportation Multi-Modal Plan, SAP GL Account 6101100 Interfund Transfer In, by the amount \$8,998.24.
- **SECTION 6.** Funds are authorized to be received from TXDOT to SAP Fund 46099000, Grants Other Projects, SAP Project Definition 40-00459, Strategic Transportation Multi-Modal Plan, and the budget shall be revised by increasing WBS element 40-00459-90-14-02 entitled Transfer from I/O# 14000000186 TXDot Grant (City), SAP GL Account 6101100 Interfund Transfer In, by the amount \$8,998.24.
- **SECTION 7.** The amount of \$44,991.20 is appropriated in SAP Fund 46099000, Grants Other Projects, SAP Project Definition 40-00459, Strategic Transportation Multi-Modal Plan, and the budget shall be revised by increasing SAP WBS Elements as follows:

Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 9. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
