AN ORDINANCE 2015 - 04 - 02 - 0244

AUTHORIZING THE EXECUTION OF AN AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH THC, INC. TO INCREASE THE CONTRACT VALUE BY UP TO \$8,000,000.00 SUBJECT TO RECEIPT AND EXECUTION OF THE NEW FEDERAL AVIATION ADMINISTRATION (FAA) GRANT OFFER FOR THE RATP TO BE AWARDED IN SEPTEMBER 2015.

WHEREAS, in December 2014 City Council authorized the submittal of a grant application to the Federal Aviation Administration (FAA) and acceptance of the grant offer for up to \$8,000,000.00 for the Residential Acoustical Treatment Program (RATP) which is managed by THC, Inc.; and

WHEREAS, this Ordinance will authorize the City Manager or her designee to amend the Professional Services Agreement with THC, Inc. upon receipt and execution of the new FAA grant offer for the RATP to be awarded in September 2015; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is hereby authorized to execute an amendment to the Professional Services Agreement with THC, Inc. for the management of the Residential Acoustical Treatment to increase the contract value by up to \$8,000.000.00 subject to receipt and execution of the Federal Aviation Administration grant offer for the Residential Acoustical Treatment Program to be awarded in 2015.

SECTION 2. Payment in an amount not to exceed \$8,000,000.00, in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00170, Residential Acoustical Treatment Program, is authorized to be encumbered and made payable to THC, Inc., for professional services. Payments for services are contingent upon the availability of funds and subject to receipt and execution of the new Federal Aviation Administration (FAA) grant offer for the RATP to be awarded in September 2015.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
