A RESOLUTION 2015-04-02-0025R

SUPPORTING THE PASSAGE OF LEGISLATION DURING THE 84TH LEGISLATIVE SESSION THAT PROVIDES FUNDING FOR THE G. J. SUTTON BUILDING IN SAN ANTONIO.

WHEREAS, Garlington Jerome (G.J.) Sutton was the first black elected State representative from San Antonio who, in an effort to save funds and revitalize the St. Paul Square neighborhood, proposed that the State of Texas buy an office building in his district; and

WHEREAS, appropriations after his death in 1976 made possible the dedication of the G.J. Sutton State Office Complex in his honor in 1982, however the building has fallen into disrepair and is now vacant; and

WHEREAS, because the building is located in EastPoint - an area the City has targeted for redevelopment - and the federally-designated Promise Zone, City Council included in its 84th Legislative Program support for the redevelopment of the G. J. Sutton Building and the appropriations request by the Texas Facilities Commission for the renovation or reconstruction of the building in order to support and not inhibit redevelopment efforts on the City's east side; and

WHEREAS, State House and Senate Appropriations bills include funding for the G. J. Sutton Building and it is the desire of City Council to reaffirm its support on this matter; NOW **THERFORE:**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. City Council reaffirms its support for legislation providing funding for the G.J. Sutton Building in San Antonio.

SECTION 2. Staff is directed to inform the Bexar County Legislative Delegation of this position and is authorized to undertake such steps as are reasonably necessary to accomplish this initiative during the 84th Legislative Session.

SECTION 3. This Resolution is effective immediately upon the receipt of eight affirmative votes.
