AN ORDINANCE 2015 - 04 - 16 - 0306

AUTHORIZING THE EXECUTION OF A UTILITY RELOCATION AGREEMENT WITH KOCH PIPELINE COMPANY, L.P. IN AN AMOUNT NOT TO EXCEED \$1,021,959.00 FOR PIPELINE ADJUSTMENTS WITHIN THE PEGGY DRIVE EXTENSION PROJECT, A 2012-2017 BOND PROGRAM FUNDED PROJECT, LOCATED IN COUNCIL DISTRICT 2.

* * * * *

WHEREAS, the 2012-2017 General Obligation Bond Program authorized \$5,600,000.00 for the Peggy Drive Extension Project and of that amount \$1,021,959.00 will be used for adjusting existing dual 16-inch fuel pipelines; and

WHEREAS, the balance of the Project funds will be used to construct the Peggy Drive Extension Project once the pipeline adjustments are complete; and

WHEREAS, the existing dual 16-inch fuel pipelines are in an existing 55' pipeline easement and the fuel pipelines must be adjusted to allow for the extension of future stub-outs for future drainage improvements to the north in the Eastgate Subdivision; and

WHEREAS, the pipeline will be lowered to a depth of approximately 10 feet from the existing grade to allow for proper clearance from the proposed drainage improvements in the Peggy Drive Extension project; and

WHEREAS, the Peggy Drive Extension Project will provide for the construction of a new roadway with drainage improvements, however, the pipline adjustments need to occur first in order for the project to move forward, and

WHEREAS, the construction contract award for the Peggy Drive Extension Project will be considered through a separate Ordinance when the pipelines have been adjusted; and

WHEREAS, this Ordinance authorizes an Utility Relocation Agreement with the Koch Pipeline Company, L.P. in the amount of \$1,021,959.00 to relocate its pipeline for the Peggy Drive Extension Project; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute a Utility Relocation Agreement with Koch Pipeline Company, L.P. in an amount not to exceed \$1,021,959.00 for pipeline adjustments in connection with the Peggy Drive Extension Project.

SECTION 2. The following financial adjustments are hereby approved:

a) Payment in the amount not to exceed \$1,021,959.00 in SAP Fund 45099000, General Obligation Capital Project, SAP Project Definition 40-00310, Peggy Drive Extension, is authorized to be encumbered and made payable to Koch Pipeline Company, L.P., for utility services.

b) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.
