AN ORDINANCE

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION IN AN AMOUNT UP TO \$50,000.00 TO THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE 2015 "CLICK IT OR TICKET" SELECTIVE TRAFFIC ENFORCEMENT PROGRAM; AND AUTHORIZING THE ACCEPTANCE OF FUNDS, UPON AWARD.

WHEREAS, the Texas Department of Transportation (TxDOT) has grant funds in the amount of \$50,000.00 available to the San Antonio Police Department from TxDOT's 2015 "Click It or Ticket" Selective Traffic Enforcement Program; and

WHEREAS, the grant period would be May 18, 2015, through May 31, 2015; and

WHEREAS, no City matching contribution is required; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee are hereby authorized to submit a grant application in an amount not to exceed \$50,000.00 to the TxDOT for the 2015 "Click It or Ticket" Selective Traffic Enforcement Program for the grant period May 18, 2015, to May 31, 2015. The City Manager and her designee are hereby authorized to accept said grant, if awarded under the same terms and conditions as applied for. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said application and acceptance.

SECTION 2. Fund 26059000 (Texas Department of Transportation) is hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant. Should funding be awarded, the sum of up to \$50,000.00 from the TxDOT will be appropriated in said fund. The budget attached hereto as **Exhibit I** is hereby approved.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers,

SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
