Program Standard: Morning Meeting






Program Standards Overview



Morning Meeting Overview

- Gather, greet, and share information
- Children develop community and discover what will happen in their classroom
- Simple drawings, letters, and words to facilitate learning at different development levels
- Consistent routine where children interact adults, students, and the morning message.
- Participation in two-way conversations and read and write on the message board



Morning Meeting Structure

Balance of ritual and novel experiences:

- Greeting ritual: Morning song, games, rhymes
- Social Conversations: Relevant conversations to develop oral language skills and build community
- Review of the Day: Children feel comfortable and secure when they know what to expect and follow a consistent routine
- Message Board: Pictures, familiar words, graphics, and letter links that young children read independently





- Instructional rounds throughout the year






Enrollment: Applications Received



Impact of CSHB 4 on Pre-K 4 SA





Funding

- Maximum Appropriation: \$130 million per biennium
- Commissioner to determine award per child not to exceed \$1,500 in addition to .5 ADA (approx. \$3,600 per student)

Requirements for Districts to Receive Funding

- Teach a curriculum required by TEA;
- Measure student outcomes on assessment required by TEA;
- Report assessment results to parents & TEA;



Requirements for Teachers

- Be State certified and have one of following:
- Child Development CDA;
- Montessori credential; or
- 8 yrs. Teaching experience in a nationally accredited child care program.



Requirements for Family Engagement

- Develop & Implement a Family Engagement Plan
- Based on empirical research
- Proven to have short and long-term outcomes for early childhood education



Districts may contract with Eligible Private Providers

- Eligible Private Providers must:
- Be licensed & in good standing with DFPS;
- Be accredited by a National Accred. System;
- Be a Tx. Rising Star provider with a 3 Star cert. or higher;
- Be a Tx. School Ready Participant;
- Have an existing partnership with an ISD;
- Or be accredited by the Tx. Private School Accred. Commission.
