1. The undersigned is authorized to approve an exemption.

2. An exemption according to Section 252.022 of the Local Government Code exists. More specifically, the following event has occurred:

The San Antonio Fire Department's (SAFD's) current Thermal Imagining Cameras (TICs) are past their service life. 61 cameras are over 8 years old and the imaging capability is falling outside of NFPA 1801, Standard on Thermal imagers for fire service. TICs are critical pieces of equipment that help decrease possible rescue time, allow evaluation of fire extension to reduce additional damage, and are used by rapid intervention crews to save lost or trapped firefighters in extreme situations.

The SAFD Tool and Equipment Committee evaluated different TICs from different manufacturers and found the ISG TIC to function the best in the tested fire environments. ISG TICs are currently used by the department and these continue to provide the best resolution and capabilities compared to others in the field. Replacement of similar camera brand, function and familiarity of equipment increases firefighter safety on the fire ground. The Fire Department currently has a total of 76 TICs with 61 TICs needing replacement. This purchase will leave 15 older model TICs in use in the field after the replacement.

3. Because the exemption stated above exists, the City of San Antonio intends to contract with
