**AN ORDINANCE**

**AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING  
UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED  
ANNUAL COST OF \$634,000.00: (A) BANKSON GROUP, LTD. D/B/A  
ALAMO TEES & ADVERTISING FOR PROMOTIONAL SHIRTS,  
(B) ZAMORANO ENTERPRISES, INC. FOR DECORATIVE METAL  
RECYCLING & DUAL METAL TRASH RECEPTACLES, (C)  
BROWN TRAFFIC PRODUCTS, INC. FOR TRAFFIC SIGNAL  
HEADS, AND (D) DIVERSIFIED INSPECTIONS/ITL FOR  
INSPECTION OF AERIAL APPARATUS AND GROUND LADDERS.**

**WHEREAS**, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

**WHEREAS**, these bids are from the following companies to furnish the City with: (A) Bankson Group, Ltd. d/b/a Alamo Tees & Advertising for promotional shirts, (B) Zamorano Enterprises, Inc. for decorative metal recycling & dual metal trash receptacles, (C) Brown Traffic Products, Inc. for traffic signal heads, and (D) Diversified Inspections/ITL for inspection of aerial apparatus and ground ladders; and

**WHEREAS**, this ordinance approves three low bid contracts and one contract on the basis of low qualifying bid; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The bids of the following companies to furnish the City with: (A) Bankson Group, Ltd. d/b/a Alamo Tees & Advertising for promotional shirts, (B) Zamorano Enterprises, Inc. for decorative metal recycling & dual metal trash receptacles, (C) Brown Traffic Products, Inc. for traffic signal heads, and (D) Diversified Inspections/ITL for inspection of aerial apparatus and ground ladders on an annual contract basis as shown on the attached bid tabulation sheets, are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

**SECTION 2.** The amounts will be encumbered upon issuance of various purchase orders, and payment is authorized to the vendors identified herein. All current fiscal year expenditures will be in accordance with the Fiscal Year 2015 budget approved by City Council, and future fiscal

year expenditures are contingent upon future City council budget approvals. The combined estimated cost for the contracts listed on this ordinance is approximately \$634,000.00.

**SECTION 3.** It has been found and declared that the bids from Allied Advertising Agency, Inc., Bid 1 and Bid 2, for Promotional Shirts, failed to meet the City's specifications and/or requirements and/or were incomplete.

**SECTION 4.** This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
