The City Clerk read the caption for Item 20:

**20.** A Resolution declaring the Friday before Mother's Day as "Military Spouse Appreciation Day." [Carlos Contreras, Assistant City Manager; Jeff Coyle, Director, Intergovernmental Relations]

Councilmember Gallagher stated that Military Spouse Appreciation Day began in 1984 through a Proclamation by President Ronald Reagan which recognized the importance of spousal commitment for Service Members of Active Duty National Guard and Reserves. He noted that it became an official part of National Military Appreciation Month in 1999 and recognized Navy Veteran Dave Etter. Mr. Etter thanked the City Council and stated that he was honored to support the Resolution. He noted that it was important for Military Members to be Mission-Focused and they were able to do so when they had support on the home front.

Councilmember Krier added his support and recognized Bobbye Hamilton of the Planning and Community Development Department for supporting her Husband and Son when they served in the Military. Mayor Taylor thanked Councilmember Gallagher for initiating the Resolution and recognized Stephanie West who works in her office for her family support during her Husband's Military Service.

Councilmember Gallagher moved to approve the Resolution. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Councilmember Gallagher stated that San Antonio was honored to be a destination that Veterans call home after leaving the military. He noted that the Purple Heart was awarded to U.S. Members of the Armed Forces that are wounded by an instrument of war in the hands of the enemy. He stated that it was also awarded posthumously to the next of kin of those killed or that died of wounds received in action. He thanked Members of the Alamo Chapter 1836, the Local Chapter of the Military Order of the Purple Heart and recognized those present to come forward. Mr. Bill E. Crumlett, representing the Military Order of the Purple Heart thanked the City Council for the Resolution and stated that there were many Active Duty and Retired Military Members in San Antonio. He presented the City Council with a Purple Heart Shield. Gilbert Brown added that San Antonio was the largest Chapter of the Purple Heart Recipients in the United States and thanked the City Council for the Resolution.

Councilmember Krier thanked Councilmember Gallagher for bringing forth the Resolution and stated that he was grateful for the work of the Military. Councilmember Viagran stated that they were honored by the Military Work that has been accomplished and thanked the Members of the Local Chapter of the Military Order of the Purple Heart that were present.

Councilmembers Nirenberg and Warrick expressed their gratitude to the Military Members that were present and thanked them for their sacrifice. Mayor Taylor thanked them for their service and sacrifice.

Councilmember Gallagher moved to approve the Resolution. Councilmember Krier seconded the motion. The motion prevailed by the following vote:

Councilmember Gallagher stated that this was an important project in the Harry Wurzbach Area and asked for additional information on the Single Point Urban Interchange (SPUI). Mike Frisbie explained that there was only one other SPUI in the State of Texas but was utilized throughout the country. He stated that it would bring traffic closer together with one signalized interchange instead of having two different traffic signals. He denoted same depicted on a diagram and stated that they had received significant funding through the Metropolitan Planning Organization (MPO) Process. Councilmember Gallagher stated that it was an innovative idea that could be incorporated in other areas of the city.

Councilmember Saldaña asked for additional information regarding SPUI. Mr. Frisbie stated that it was a Single Point Urban Interchange and explained how it worked utilizing a diagram. Councilmember Saldaña expressed his support and commended the Traffic Engineers that designed the methodology.

Councilmember Gallagher moved to adopt the proposed ordinances for Items 11A and 11B. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

An Ordinance authorizing the submission of a grant application in an amount up to \$650,000.00 to the U.S. Department of Justice for a grant from the 2015 Enhanced Collaborative Model to Combat Human Trafficking Competitive Solicitation to support the development and enhancement of a multidisciplinary human trafficking coalition; authorizing an in-kind matching contribution of \$216,667.00; and authorizing the acceptance of the funds, upon award. [Erik J. Walsh, Deputy City Manager; Anthony L. Treviño, Jr., Interim Police Chief]

Councilmember Viagran thanked Chief Treviño for his efforts and noted that she had initiated a Council Consideration Request (CCR) to combat Human Trafficking. She stated that although funding was not available; they had created a Public Service Announcement and were applying for grants to combat all forms of Human Trafficking. Chief Treviño presented a Power Point noting that Human Trafficking involved the recruitment, harboring, and transportation of persons for involuntary labor or services or forced commercial sex acts. He provided SAPD Statistics in which 16 investigations with 22 victims and nine cases were filed in 2013. He noted that in 2014; 50 investigations, 58 victims, and 13 cases were filed. He noted that a Task Force had been created which included representatives from SAPD, Alamo Area Rape Crisis Center, US Attorney's Office, and Homeland Security Investigations. He reported that if awarded, they would receive funding in the amount of \$650,000 over a three-year period. He noted that matching funds of \$216,667 would be required which would consist of the salaries of existing Detectives. He played a 30-second portion of a 15-minute educational video that was released the previous day. He added that they had produced seven 35-second Public Service Announcements with Police Officers speaking different languages and reaching out to victims of Human Trafficking. He spoke of their outreach efforts noting that they were working with Region XX to release the information to the 11 Counties they work with. Councilmember Viagran expressed her support and stated that she was pleased that they were addressing this very serious issue.

Councilmember Gonzales asked of the process of applying for said grant. Chief Treviño responded that they had previously applied for similar grants and had not received them. He stated that they had reached out to the Grantor to ask how they could improve their application and hoped to receive it. Councilmember Gonzales asked of the potential to apply for other grants. Chief Treviño replied that there was additional grant funding

available and they would apply for funding for specific programs when the opportunity was available. Councilmember Gonzales asked of potential signs to look for regarding Human Trafficking. Chief Treviño provided the example of having laundry soap and laundry in plastic bags in the back seat of a car which could indicate that they are moving people around.

Councilmember Medina stated that they had an obligation to protect the most vulnerable population in the community and stated that he was optimistic that they would receive the grant. Mayor Taylor added her thanks to Councilmember Viagran for her work on the issue and spoke of its impact on the community.

Councilmember Viagran moved to adopt the proposed ordinance. Councilmember Treviño seconded the motion.

Mayor Taylor stated that she had submitted the recusal forms to the City Clerk and exited the Council Chambers. Mayor Pro Tem Warrick presided over said item and stated that it had been pulled for recusal purposes only.

Councilmember Saldaña moved to adopt the proposed ordinance. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

The City Clerk read the caption for Item 25A:

Councilmember Saldaña highlighted the North Airfield at Port San Antonio and asked how would be utilized. Jorge Beltran of the Economic and Community the funding Development Department stated that this was a redirection of previously approved Economic Development Incentive Funds (EDIF). He noted that Port San Antonio would use the funds for the North Airfield Project and Jet Engine Test Cell Facility to address flooding issues. Roland Mower, CEO of Port San Antonio addressed the Council and explained that they were preparing the North Airfield Site for development and would demolish five buildings as well as remove pavement and debris. Councilmember Saldaña stated that once it was ready; the North Airfield would provide 3,000 job opportunities. He added that he hoped the positions could be filled by graduates of the Alamo Academies.

Councilmember Saldaña moved to adopt the proposed ordinance for Item 25A. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

Mr. Jack M. Finger stated that he was pleased that Item Z-9 would not be addressed noting that there was a great amount of opposition. He noted that he was opposed to Item Z-16 as he did not feel that a multi-family complex should be authorized by single-family homes. He expressed opposition to Item Z-19 due to the amount of opposition.

Written testimony was received in support of Item Z-7 from Gary Woods, Bernard T. Swift, Jr., and Reuben Bar-Yardin.

Written testimony was received from Faris Hodge, Jr. in favor of Items Z-1 through P-2, and Z-10 through Z-19. He wrote in opposition to Item Z-9.

Consultation shall be initiated with the City Arborist to select appropriate landscaping. 2) An 8-foot solid masonry fence as illustrated in the site plan shall be maintained where the subject property abuts residential

zoning or uses. 3) Collection of any on-site dumpsters shall be limited to the hours of 7:00 am to 9:00 pm and dumpsters must be screened on at least 3 sides. 4) All onsite lighting shall be directed onto the site and point away from any residential zoning or uses. 5) No outdoor speaker or amplification systems shall be permitted. 6) Hours of Operation for the Auto and Light Truck Repair Use (the Conditional Use) shall be limited to the hours of 7:00 am to 6:00 pm Monday through Friday and 8:00 am to 4:00 pm on Saturday and the business will be closed on Sundays. Garage doors will close when the repair shop closes. 7) Auto and Light Truck Repair use will only occur within the footprint shown on the Conditional Use Site Plan. He reported that of 23 notices mailed; none were returned in favor and one was received in opposition.

Mayor Taylor called upon Mr. Carlos Madero to speak.

Mr. Carlos Madero, President of the Tanglewood Resident's Association stated that they had worked with the Applicant and were in support of the request.
