AN ORDINANCE

AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$341,000.00: (A) BROWN TRAFFIC PRODUCTS, INC. FOR EXTENDED VIEW LED TRAFFIC SIGNAL LAMPS, AND (B) CENTERLINE SUPPLY FOR TRAFFIC POSTS AND HARDWARE.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, these bids are from the following companies to furnish the City with: (A) Brown Traffic Products, Inc. for extended view led traffic signal lamps, and (B) Centerline Supply for traffic posts and hardware; and

WHEREAS, this ordinance approves one low bid contract, and one contract awarded to other than the low bidder because the low bidder did not meet the City's specifications or requirements; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bids of the following companies to furnish the City with: (A) Brown Traffic Products, Inc. for extended view led traffic signal lamps, and (B) Centerline Supply for traffic posts and hardware on an annual contract basis as shown on the attached bid tabulation sheets, are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. The amounts will be encumbered upon issuance of various purchase orders, and payment is authorized to the vendors identified herein. All current fiscal year expenditures will be in accordance with the Fiscal Year 2015 budget approved by City Council, and future fiscal year expenditures are contingent upon future City Council budget approvals. The combined estimated cost for the contracts listed on this ordinance is approximately \$341,000.00.
