WHEREAS, Collins Garden Library was opened and officially dedicated in December 1984 and last improvements made in 1996; and

WHEREAS, this project provides for exterior improvements, to include new sliding entry doors, enclosing the front entry to mitigate pigeon infestation and increase in usable square footage adding about 700 square feet to the interior; and

WHEREAS, interior renovation work includes, Americans with Disabilities Act (ADA) restroom upgrades, new carpet and book shelves, security cameras and card readers, in addition to staff and computer workstations and the relocation of the circulation desk; and

WHEREAS, site work includes repairs to deteriorated brick sidewalks and a new District 5 Council office that will have a separate entrance with a storefront glass entry and the addition of a security curtain sliding gate, to close off this office when not in use; and

WHEREAS, project construction is anticipated to begin in July 2015 and is estimated to be completed by December 2015; and

WHEREAS, this project was advertised for construction bids in March 2015 in the San Antonio Hart Beat, on the City's website, on the Texas Electronic State Business Daily, on TVSA and through the Transportation and Capital Improvements Small Business Office; and

WHEREAS, plans also were available to potential bidders at the office of Alvidrez Architects located at 110 Broadway, Suite 450, San Antonio, TX 78205; and

WHEREAS, bids were opened on April 7, 2015 and four (4) bids were received and of these, MGB Group, Inc., submitted the lowest qualified responsive bid; and

WHEREAS, this contract will be awarded in compliance with the Small Business Economic Development Advocacy (SBEDA) Program, which requires contracts be reviewed by a Goal Setting Committee to establish a requirement and/or incentive unique to the particular contract in an effort to maximize the amount of small, minority, and women-owned business participation on the contract; and

WHEREAS, the Goal Setting Committee set a 25% Minority/Women Business Enterprise (M/WBE) subcontracting goal and 4% African American Business Enterprise (AABE) subcontracting goal; and

WHEREAS, the Economic Development Department approved a waiver submitted by MGB Group, Inc. because the contractor demonstrated a good faith effort to provide subcontracting opportunities for small, minority, and women-owned businesses; and

WHEREAS, MGB Group, Inc. is also a certified small business; and

WHEREAS, this construction contract was developed utilizing the Qualified Low Bid process; therefore, a Discretionary Contracts Disclosure Form is not required; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive qualified bid in the amount of \$654,939.00 from MGB Group Inc., for Collins Garden Library, a FY 2015 Deferred Maintenance and Facilities Services Fund Project, is hereby accepted. 

1) Project Name: Renovation of Hangar Building 11108

2) Project Scope, Location: The project consisted of the design and renovation of the south-central 3-story tower inside Hangar Building 11108 (B-52 Hangar) at Biggs Field, Texas. The project consisted of complete demolition of the office, warehouse and shop areas within the tier building and reconstruction into a well-planned and efficient operations area for a Hangar aircraft operator. The tier roof and building envelope incorporated a high expansion foam fire suppression system. Work also included the removal of up to 1000 transite panels throughout the Hangar building's façade. The panels removed consisted of damaged, missing, or panels previously replaced with unapproved materials. These removed panels were replaced with a corrugated panel section matching the color, texture, and corrugation pattern of the original panels to meet U.S. Department of the Army historical criteria. Additionally, we prepared documentation for certification of the tier building at Silver Level of LEED®. Our scope of work also included the design and construction of a rigid pavement structure to match existing pavements, for automobile parking and driveway areas along the perimeter of the building. The hangar building also served as a storage area for the planes used in training. We talked to the building manager and staged our equipment and materials in a small section of the parking lot, which was fenced to ensure our equipment was not damaged. The project was located at Biggs Army Airfield, Ft. Bliss, Texas.
