AN ORDINANCE 2015 - 06 - 18 - 0 5 7 0

AUTHORIZING THE EXECUTION OF AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF SAN ANTONIO AND NORTH EAST INDEPENDENT SCHOOL DISTRICT IN THE AMOUNT NOT TO EXCEED \$40,000.00 FOR CONSTRUCTION RELATED TO THE HIDDEN FOREST ELEMENTARY SCHOOL DRAINAGE IMPROVEMENTS PROJECT, LOCATED IN COUNCIL DISTRICT 9.

WHEREAS, during major storm events, runoff from a portion of the Hidden Forest Elementary School campus drains between two adjacent residential properties located behind the school campus which has resulted in past property flooding and damage; and

WHEREAS, there is an existing Drainage Right-of-Way with an underground storm water system (pipe) located between these two properties which has been determined to be undersized; and

WHEREAS, the City and the North East Independent School District have proposed a joint partnership to improve the overall drainage system which serves this area and help alleviate future flooding to the neighboring residential properties; and

WHEREAS, the North East Independent School District will design and construct the Hidden Forest Elementary School Drainage Improvements and the City will contribute up to 60% of the construction costs to improve the overall drainage system which serves this area; and

WHEREAS, this Ordinance authorizes the execution of an Interlocal Agreement with the North East Independent School District in the amount of \$40,000.00 to be paid from the Storm Water Operating Fund for the Hidden Forest Elementary School Drainage Improvements Project; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute an Interlocal Agreement between the City of San Antonio and **North East Independent School District** for the Hidden Forest Elementary School Drainage Improvements Project. The Agreement must be executed by all parties within 90 days of signing of this Ordinance; otherwise, the Agreement must be considered through a subsequent Ordinance.

SECTION 2. The following financial adjustments are hereby approved:

a) Funding in the amount of \$40,000.00 for this ordinance is available for Fund 29070000, Cost Center 2304050001 and General Ledger 5201040, as part of the Fiscal Year 2015 Budget.

- b) Payment not to exceed the budgeted amount is authorized to **North East Independent School District** and should be encumbered with a purchase order.
- c) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
