## AN ORDINANCE

AUTHORIZING THE RENEWAL OF A CONTRACT WITH THE UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER DENTAL SCHOOL FOR AN AMOUNT UP TO \$181,561.00, FOR THE PROVISION OF DENTAL SERVICES FOR A PERIOD BEGINNING SEPTEMBER 1, 2015 THROUGH AUGUST 31, 2016.

**WHEREAS,** on an annual basis, the San Antonio Metropolitan Health District's (Metro Health) Dental Program provides diagnostic and preventive care to more than 12,000 children living in poverty by providing services in non-traditional settings, such as Head Start, Early Head Start and on campuses of local Title I elementary schools; and

**WHEREAS,** through these programs, many children are identified with additional dental treatment needs beyond the scope of Metro Health services; and

WHEREAS, case management services are provided by Metro Health dental staff to assist participating children to receive needed treatment and to connect families to a source of ongoing care in the community; and

**WHEREAS**, approximately 23% of children enrolled in the City's Head Start Program are not covered through Texas Medicaid or the Children's Health Insurance Plan (CHIP); and

WHEREAS, historically, Metro Health has contracted with the University of Texas Health Science Center San Antonio (UTHSCSA) Dental School as a cost-effective means of providing access to high quality dental care for children throughout the community who are uninsured or underinsured; and

WHEREAS, these children are identified through City outreach programs that have extensive dental needs beyond the scope of services offered by Metro Health; and

**WHEREAS**, the renewal of the contract with the UTHSCSA Dental School will ensure pediatric patients identified through the program who are either uninsured or underinsured, have access to critical dental health services; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or her designee, or the Director of the San Antonio Metropolitan Health District or his designee is authorized to execute the renewal contract with the University of

Texas Health Science Center Dental School for an amount up to \$181,561.00, forthe provision of dental services for a period beginning September 1, 2015 through August 31, 2016. A copy of the contract, in substantially final form, is attached hereto and incorporated herein for all purposes as **Attachment I.** 

**SECTION 2.** Fund 26016xxxxx entitled "Title V Dental Fee for Service - 2016" and Internal Order 136000000xxx are hereby designated for use in the accounting for the fiscal transaction in the acceptance of this agreement.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** The sum of \$181,561.00 is hereby appropriated in the above designated fund and will be disbursed from GL 5201030 "Fees to Government Contractors." Payment is authorized to the University of Texas Health Science Center at San Antonio Dental School upon issuance of a purchase order.

**SECTION 5.** This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
