# AN ORDINANCE 2015 - 08 - 13 - 0693

### AUTHORIZING AN AMENDMENT IN AN AMOUNT NOT TO EXCEED \$124,000.00 TO THE PROFESSIONAL SERVICES AGREEMENT WITH INTERVISTAS CONSULTING, INC. FOR ADDITIONAL AIR SERVICES DEVELOPMENT AND AIRLINE CONSULTING SERVICES FOR SAN ANTONIO INTERNATIONAL AIRPORT.

WHEREAS, in August 2012 the City and InterVISTAS Consulting LLC (now InterVISTAS Consulting Inc.) entered into a professional services agreement for air service development and airline analysis consulting for San Antonio International Airport; and

WHEREAS, the City created the Air Service Task Force which utilizes the personnel and expertise of InterVISTAS resulting in increased air service development activity over and above what was anticipated requiring additional contract capacity; and

WHEREAS, it is necessary to amend the Professional Services Agreement with InterVISTAS to increase the contract amount by an amount not to exceed \$124,000.00; NOW THEREFORE,

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager, or her designee, is authorized to execute the amendment to the Professional Services Agreement with InterVISTAS Consulting Inc. to increase the fee for services by an amount not to exceed \$124,000.00, a copy of which is set out in **Exhibit 1**.

**SECTION 2.** Funding in the amount of \$124,000.00 for this ordinance is available for Fund 51001000, Cost Center 3305010002 and General Ledger 5201040, as part of the Fiscal Year 2015 Budget.

**SECTION 3.** Payment not to exceed the budgeted amount is authorized to InterVISTAS Consulting Inc. and should be encumbered with a purchase order.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

### AMENDMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT FOR AIR SERVICE DEVELOPMENT AND AIRLINE ANALYSIS SERVICES AT SAN ANTONIO INTERNATIONAL AIRPORT

This Amendment (herein called the "Amendment") to the Professional Services Agreement for Air Service Development and Airline Analysis Services at San Antonio International Airport is entered into by and between the City of San Antonio (herein called the "City"), a Texas municipal corporation, acting by and through its City Manager, and InterVISTAS Consulting, Inc. (hereinafter called "Consultant") acting by and through its designated officer(s), both of which may be referred to herein collectively as the "Parties", as set out below. WITNESSETH:

WHEREAS, in July, 2012 the City and InterVISTAS Consulting, LLC (now InterVISTAS Consulting, Inc.) entered into the Professional Services Agreement for Air Service Development and Airline Analysis Services at San Antonio International Airport (the "Agreement") pursuant to Ordinance No. 2012-08-30-0656; and

WHEREAS, as a result of the increased air service development activity over and above what was anticipated, the parties desire to increase the total not to exceed contract amount by \$124,000.00; and

**NOW THEREFORE,** in consideration of the terms, covenants, agreements and demises herein contained, and in consideration of other good and valuable consideration, each to the other given, the sufficiency and receipt of which are hereby acknowledged, the Agreement entered into by and between the City and the Consultant is amended as follows:

1. Article V. Compensation, Section 5.2. The total not to exceed contract sum is hereby increased by \$124,000.00 for a revised total not to exceed contract sum of ONE MILLION, TWENTY-FOUR THOUSAND AND 00/100 U.S. DOLLARS (\$1,024,000.00).

Except as amended hereby, all other provisions of the Agreement are hereby retained in their entirety and remain unchanged.
