2. DISCUSSION AND POSSIBLE ACTION ON A RECOMMENDATION TO THE BOARD OF DIRECTORS REGARDING A LOAN AGREEMENT WITH LOUIS ESCARENO IN AN AMOUNT UP TO \$70,000

Ms. Van Coney briefed the committee on the application from Mr. Escareño for a loan of \$70,000 for the purpose of improvements for expansion of his existing business on West Martin Street. The committee members inquired about the applicant's business operations and financials. Based on the applicant's credit score and proposed terms from other financial institutions, the committee wondered if the applicant would be able to reduce the loan principal amount asked for from WDC and increase the amount sought from other financial institutions with competitive terms. The committee's recommendation would be based on this assumption.

Mr. Radle moved to recommend a \$40,000 principal loan for an 84-month term at 4% interest. Mr. Rattan provided a second. Motion carried.

3. DISCUSSION AND POSSIBLE ACTION ON A RECOMMENDATION TO THE BOARD OF DIRECTORS REGARDING A LOAN AGREEMENT WITH ROBERT JARAMILLO, DBA RENE ROBERTS HAIR STUDIO.
